1 **An Act to establish fees for information provided from the statewide voter**
 2 **registration file.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1. That chapter 12-4 be amended with a NEW SECTION:**

5 The fees for obtaining a copy of an electronic file with voter registration information
 6 are as follows:

7 (1) Statewide complete file, two thousand five hundred dollars;

8 (2) Statewide complete file for new parties or parties with alternative political status
 9 for just their party voters:

10 (a) Fifteen dollars for one thousand names or less;

11 (b) Fifty dollars for one thousand one to ten thousand names, inclusive;

12 (c) One hundred dollars for ten thousand one to twenty-five thousand names,
 13 inclusive; and

14 (d) Two hundred fifty dollars for more than twenty-five thousand names;

15 (3) Legislative district complete file, one hundred dollars;

16 (4) County or any other district complete file:

17 (a) Fifteen dollars for one thousand names or less;

18 (b) Fifty dollars for one thousand one to ten thousand names, inclusive;

19 (c) One hundred dollars for ten thousand one to twenty-five thousand names,
 20 inclusive; and

21 (d) Two hundred fifty dollars for more than twenty-five thousand names;

22 (5) Any updated partial file that contains only changes made within a year after the
 23 purchase of a complete file:

24 (a) Two hundred fifty dollars for a statewide partial file; and

25 (b) Twenty-five dollars for a legislative district, any other district, or county
 26 partial file.

1 **Section 2. That chapter 12-4 be amended with a NEW SECTION:**

2 The fees for obtaining a paper list with voter registration information are as follows:

- 3 (1) Statewide complete list, five thousand five hundred dollars;
4 (2) Statewide complete list for new parties or parties with alternative political status
5 for just their party voters:
6 (a) Twenty dollars for one thousand names or less;
7 (b) Seventy-five dollars for one thousand one to ten thousand names, inclusive;
8 (c) Two hundred dollars for ten thousand one to twenty-five thousand names,
9 inclusive; and
10 (d) Six hundred dollars for more than twenty-five thousand names;
11 (3) Legislative district complete list, two hundred dollars;
12 (4) County or any other district complete list:
13 (a) Twenty dollars for one thousand names or less;
14 (b) Seventy-five dollars for one thousand one to ten thousand names, inclusive;
15 (c) Two hundred dollars for ten thousand one to twenty-five thousand names,
16 inclusive; and
17 (d) Six hundred dollars for more than twenty-five thousand names;
18 (5) Any updated partial list that contains only changes made within a year after the
19 purchase of a complete list:
20 (a) Five hundred fifty dollars for a statewide partial list; and
21 (b) Sixty dollars for a legislative district, any other district, or county partial
22 list.

23 **Section 3. That chapter 12-4 be amended with a NEW SECTION:**

24 The fees for obtaining a copy of an electronic file with daily absentee voter
25 registration information per election are as follows:

- 26 (1) Statewide complete file, three thousand dollars;
27 (2) Legislative district complete file, one hundred fifty dollars; and
28 (3) County complete file:
29 (a) Sixty-five dollars for one thousand names or less;
30 (b) One hundred dollars for one thousand one to ten thousand names,
31 inclusive;
32 (c) One hundred fifty dollars for ten thousand one to twenty-five thousand
33 names, inclusive; and

1 (d) Three hundred dollars for more than twenty-five thousand names.

2 **Section 4. That § 12-4-39 be AMENDED:**

3 **12-4-39.** The secretary of state may promulgate rules pursuant to chapter 1-26
4 concerning:

5 (1) Procedures for the establishing the statewide voter registration file;

6 (2) Transmission of the voter registration information from the county to the Office of
7 the Secretary of State;

8 (3) Procedures for determining duplicate voter registration; and

9 (4) Dissemination of the information from the statewide voter registration file; ~~and~~

10 ~~(5) Establishment of fees for information provided from the statewide voter registration~~
11 file.
