## HOUSE BILL NO. 1222

- 1 FOR AN ACT ENTITLED, An Act to provide that any federal law that attempts to ban
- 2 firearms, to limit the size of firearm magazines, or to impose other limitations on firearms
- is unenforceable in South Dakota, to provide a penalty, and to declare an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 5 Section 1. That chapter 37-35 be amended by adding thereto a NEW SECTION to read as
- 6 follows:
- No public employee as defined in § 3-21-1, or dealer selling any firearm in this state may
- 8 enforce or attempt to enforce any act, law, statute, rule, or regulation of the United States
- 9 government relating to a personal firearm, firearm accessory, or ammunition that is owned or
- manufactured commercially or privately in South Dakota and that remains exclusively within
- 11 the borders of South Dakota.
- 12 Section 2. That chapter 37-35 be amended by adding thereto a NEW SECTION to read as
- 13 follows:
- Any official, agent, or employee of the United States government who enforces or attempts

- to enforce any act, order, law, statute, rule, or regulation of the United States government upon
- 2 a personal firearm, a firearm accessory, or ammunition that is owned or manufactured
- 3 commercially or privately in South Dakota and that remains exclusively within the borders of
- 4 South Dakota is guilty of a Class 6 felony and, upon conviction, is subject to imprisonment for
- 5 not less than one year, a fine of not more than four thousand dollars, or both.
- 6 Section 3. That chapter 37-35 be amended by adding thereto a NEW SECTION to read as
- 7 follows:
- 8 The attorney general may defend a citizen of South Dakota who is prosecuted by the United
- 9 States government for violation of a federal law relating to the manufacture, sale, transfer, or
- 10 possession of a firearm, a firearm accessory, or ammunition owned or manufactured and
- retained exclusively within the borders of South Dakota.
- 12 Section 4. That chapter 37-35 be amended by adding thereto a NEW SECTION to read as
- 13 follows:
- Any federal law, rule, regulation, or order created or effective on or after January 1, 2013,
- is unenforceable within the borders of South Dakota if the law, rule, regulation, or order
- 16 attempts to:
- 17 (1) Ban or restrict ownership of a firearm or any magazine of a firearm; or
- 18 (2) Require any firearm, magazine, or other firearm accessory to be registered in any
- manner.
- Section 5. Whereas, this Act is necessary for the immediate preservation of the public peace,
- 21 health, or safety, an emergency is hereby declared to exist, and this Act shall be in full force and
- 22 effect from and after its passage and approval.
