- 1 FOR AN ACT ENTITLED, An Act to make an appropriation to fund the Teach for America
- 2 grant program.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That § 13-55-62 be amended to read as follows:
- 5 13-55-62. There is hereby created a Teach for America grant program within the Department
- 6 of Education. The purpose of the grant program is to provide funding to Teach for America, a
- 7 nonprofit organization that provides alternative teacher recruitment and placement in public
- 8 schools in which a majority of the students are from low-income households. Through the grant
- 9 program, the state will partner with private contributors to fund an expansion of the Teach for
- America program in the state that will allow the number of teachers placed to grow from fifty-
- seven to one hundred by 2015. The expansion will allow Teach for America to positively impact
- 12 two-thirds of the Native American students on reservations in the state and more than half of
- 13 the Native American students statewide, and to strengthen its efforts to improve the academic
- 14 achievement of low-income, Native American students and to increase the educational

- 1 opportunities afforded them.
- Funding through appropriated for the grant program in fiscal year 2014 shall be provided
- 3 to Teach for America over a period of four fiscal years beginning on July 1, 2012. Funding
- 4 appropriated for the grant program pursuant to this Act shall be provided to Teach for America
- 5 over a period of four fiscal years beginning on July 1, 2014. The amount of the grants provided
- 6 pursuant to this section and § 13-55-63 shall be based upon the amount of matching funds
- 7 received by Teach for America from private contributors, but the total amount of all grants
- 8 provided may not exceed the total amount of money appropriated for the grant fund.
- 9 Section 2. There is hereby appropriated from the general fund the sum of five hundred
- thousand dollars (\$500,000), or so much thereof as may be necessary, to the Department of
- Education to provide funding for the Teach for America grant program established in § 13-55-
- 12 62.
- 13 Section 3. The secretary of education shall approve vouchers and the state auditor shall draw
- warrants to pay expenditures authorized by this Act.
- 15 Section 4. Any amounts appropriated in this Act not lawfully expended or obligated shall
- revert in accordance with the procedures prescribed in chapter 4-8.
