That chapter 2-6 be amended by adding a NEW SECTION to read: 4 There is hereby created the Special Education Task Force. The purpose of the task force is 5 to examine the rising numbers of students in South Dakota schools who are being identified as 6 in need of special education or special education and related services, to examine the increasing 7 costs of the services these students require, and to develop recommendations to address the 8 situation. 9 Section 2. That chapter 2-6 be amended by adding a NEW SECTION to read: 10 The task force created in section 1 of this Act shall consist of the following twelve members: 11 (1) The Executive Board of the Legislative Research Council shall appoint the following: 12 (a) Three legislators including, if possible, the chair or vice-chair of the Senate 13 standing committee on education and the chair or vice-chair of the House
