AN ACT to amend Tennessee Code Annotated, Title 48, Chapter 11, Part 3; Title 48, Chapter 247, Part 1; Title 48, Chapter 249, Part 10; Title 48, Chapter 51, Part 3; Title 61, Chapter 1, Part 12; Title 61, Chapter 2, Part 12 and Title 61, Chapter 3, Part 12, relative to fees.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 48-11-303(a)(8), is amended by deleting the subdivision and substituting the following:

(8) Corporation's statement of change of registered agent \$20.00

SECTION 2. Tennessee Code Annotated, Section 48-11-303(a)(9), is amended by deleting the subdivision and substituting the following:

(9) Registered agent's statement of change of registered office No Fee

SECTION 3. Tennessee Code Annotated, Section 48-11-303(a)(10), is amended by deleting the subdivision and substituting the following:

(10) Registered agent's statement of resignation No Fee

SECTION 4. Tennessee Code Annotated, Section 48-51-303(a)(8), is amended by deleting the subdivision and substituting the following:

(8) Corporation's statement of change of registered agent \$20.00

(7) Registered agent's statement of change of registered office No Fee;

SECTION 21. Tennessee Code Annotated, Section 61-3-1205(a)(8), is amended by deleting the subdivision and substituting the following:

(8) Registered agent's statement of resignationNo Fee;

SECTION 22. This act shall take effect July 1, 2021, the public welfare requiring it.
