WHEREAS, Mr. O'Hare directed the Hawaii Armed Forces Airshow, which is held at Kaneohe Marine Corps Base, four times, most recently in 2022, and he founded the Hixson Museum of Flight at Dallas Bay over a decade ago, with the intent to increase the awareness of flight while also supporting the local children's hospital; and

WHEREAS, devoted to aviation, he helped numerous young men and women enter and advance their careers in either aviation or the military, and he flew countless chronically ill children himself to give them the experience of flight; and

WHEREAS, he was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Mr. O'Hare enjoyed the loving companionship of his wife, Susan O'Hare, and was the proud father of Savannah Mello; and

WHEREAS, Peter O'Hare leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and

WHEREAS, it is fitting that the members of this General Assembly should pause to remember the bountiful life of this exceptional public servant and human being; now, therefore,
