A RESOLUTION to recognize Hunter Robertson Beasley on becoming an Eagle Scout.

WHEREAS, at a time when this nation's youth face difficult challenges, the Boy Scouts of America is one of our finest assets, providing young men and women with an educational program that contributes significantly to their character development, citizenship training, and improved mental and physical fitness; and

WHEREAS, the highest rank a Scout can attain in the Boy Scouts of America Scouts BSA program is that of Eagle Scout, and Hunter Robertson Beasley, after considerable effort and diligent preparation, has joined the prestigious Eagle Court of Honor; and

WHEREAS, Hunter Beasley has demonstrated considerable ability as a leader among his peers; and

WHEREAS, his notable record of achievement as a member of Boy Scout Troop 154 includes numerous merit badges and distinguished service; he has also hiked more than 100 miles, including a high-elevation hike in the mountains of New Mexico; and

WHEREAS, for his Eagle project, Hunter Beasley helped sponsor a historical marker at Chickasaw Trace Park and improved the site by cleaning off an overgrown cemetery and setting up memorial benches, as well as installing additional historical signage at the park; and

WHEREAS, thanks to Mr. Beasley's diligent efforts, the Tennessee Historical Commission placed the Derryberry Log House/Wisener-Church House Site historical marker at Chickasaw Trace Park; the installation of the marker will provide the important history of the site to visitors for years to come; and

WHEREAS, Hunter Beasley also performed another seventy-seven hours of community service by assisting with food drives, placing flags on veterans' graves, and helping other Scouts with their projects; and

WHEREAS, Mr. Beasley's Eagle Court of Honor and the unveiling and dedication of the marker will take place on Saturday, May 11, 2024, at the site of the marker on Mary A. Church Road in Chickasaw Trace Park; and

WHEREAS, Hunter Beasley's Eagle project greatly contributed to the betterment of his community and reflected the true spirit of volunteerism; and

WHEREAS, it is appropriate that we should pause to recognize Mr. Beasley as one of the most outstanding young people in our State; now, therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRTEENTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE SENATE CONCURRING, that we hereby honor and congratulate Hunter Robertson Beasley on becoming an Eagle Scout and extend to him our best wishes for every future success.
