WHEREAS, in 1992, he became president of Sewell-Allen, as well as a partner; at the peak of the company's growth, the firm served fifteen stores and employed more than 1,200 residents of the greater Memphis area; and

WHEREAS, Mr. James currently owns three Cash Saver stores, offering the highest possible value for customers in Memphis; and

WHEREAS, he also prevented the creation of an urban food desert when, on the announcement of a store closure by a large national grocery chain, Rick James purchased the property and turned it into a thriving community resource; and

WHEREAS, similarly, Mr. James assumed ownership of a beloved neighborhood gem, High Point Grocery, preserving its legacy for another generation; and

WHEREAS, in 2022, Rick James opened downtown Memphis's first full-service grocery store in decades, South Point Grocery, thereby increasing livability in the city's vital urban core; and

WHEREAS, his long and distinguished record of civic involvement includes serving on the Memphis City Schools Strategic Planning Task Group and on the board of directors of the Memphis in May International Festival, Shelby State Community College, and the Mid-South Food Bank; and

WHEREAS, a dedicated member of his profession, Mr. James serves on the board of directors of Piggly Wiggly Owners and Operations Association and as chairman of the Tennessee Grocers and Convenience Store Association; and

WHEREAS, no stranger to accolades, Rick James is a recipient of the prestigious Peace and Justice Center Award for Outstanding Accomplishments in Business; and

WHEREAS, throughout his many successes, Mr. James has enjoyed the love and support of his wife of thirty-six years, Cathy, and together they have raised five outstanding children: Sarah, Erick, Taylor, Adelyn, and Lauren, the three youngest of whom are active in the family business; and
