# H. R. 1362

## AN ACT

To amend the Public Health Service Act to provide for the establishment of permanent national surveillance systems for multiple sclerosis, Parkinson's disease, and other neurological diseases and disorders.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “National Neurological  
3 Diseases Surveillance System Act of 2010”.

4 **SEC. 2. NATIONAL NEUROLOGICAL DISEASES SURVEIL-**  
5 **LANCE SYSTEM.**

6 Part P of title III of the Public Health Service Act  
7 (42 U.S.C. 280g et seq.) is amended by adding at the end  
8 the following:

9 **“SEC. 399V-5 SURVEILLANCE OF NEUROLOGICAL DISEASES.**

10 “(a) IN GENERAL.—The Secretary, acting through  
11 the Director of the Centers for Disease Control and Pre-  
12 vention, shall—

13 “(1) enhance and expand infrastructure and ac-  
14 tivities to track the epidemiology of neurological dis-  
15 eases, including multiple sclerosis and Parkinson’s  
16 disease; and

17 “(2) incorporate information obtained through  
18 such activities into a statistically-sound, scientif-  
19 ically-credible, integrated surveillance system, to be  
20 known as the National Neurological Diseases Sur-  
21 veillance System.

22 “(b) RESEARCH.—The Secretary shall ensure that  
23 the National Neurological Diseases Surveillance System is  
24 designed in a manner that facilitates further research on  
25 neurological diseases.

1       “(c) CONTENT.—In carrying out subsection (a), the  
2 Secretary—

3           “(1) shall provide for the collection and storage  
4 of information on the incidence and prevalence of  
5 neurological diseases in the United States;

6           “(2) to the extent practicable, shall provide for  
7 the collection and storage of other available informa-  
8 tion on neurological diseases, such as information  
9 concerning—

10           “(A) demographics and other information  
11 associated or possibly associated with neuro-  
12 logical diseases, such as age, race, ethnicity,  
13 sex, geographic location, and family history;

14           “(B) risk factors associated or possibly as-  
15 sociated with neurological diseases, including  
16 genetic and environmental risk factors; and

17           “(C) diagnosis and progression markers;

18           “(3) may provide for the collection and storage  
19 of information relevant to analysis on neurological  
20 diseases, such as information concerning—

21           “(A) the epidemiology of the diseases;

22           “(B) the natural history of the diseases;

23           “(C) the prevention of the diseases;

24           “(D) the detection, management, and  
25 treatment approaches for the diseases; and

1           “(E) the development of outcomes meas-  
2           ures; and

3           “(4) may address issues identified during the  
4           consultation process under subsection (d).

5           “(d) CONSULTATION.—In carrying out this section,  
6 the Secretary shall consult with individuals with appro-  
7 priate expertise, including—

8           “(1) epidemiologists with experience in disease  
9           surveillance or registries;

10           “(2) representatives of national voluntary  
11           health associations that—

12           “(A) focus on neurological diseases, includ-  
13           ing multiple sclerosis and Parkinson’s disease;  
14           and

15           “(B) have demonstrated experience in re-  
16           search, care, or patient services;

17           “(3) health information technology experts or  
18           other information management specialists;

19           “(4) clinicians with expertise in neurological  
20           diseases; and

21           “(5) research scientists with experience con-  
22           ducting translational research or utilizing surveil-  
23           lance systems for scientific research purposes.

24           “(e) GRANTS.—The Secretary may award grants to,  
25 or enter into contracts or cooperative agreements with,

1 public or private nonprofit entities to carry out activities  
2 under this section.

3       “(f) COORDINATION WITH OTHER FEDERAL AGEN-  
4 CIES.—Subject to subsection (h), the Secretary shall make  
5 information and analysis in the National Neurological Dis-  
6 eases Surveillance System available, as appropriate, to  
7 Federal departments and agencies, such as the National  
8 Institutes of Health, the Food and Drug Administration,  
9 the Centers for Medicare & Medicaid Services, the Agency  
10 for Healthcare Research and Quality, the Department of  
11 Veterans Affairs, and the Department of Defense.

12       “(g) PUBLIC ACCESS.—Subject to subsection (h), the  
13 Secretary shall make information and analysis in the Na-  
14 tional Neurological Diseases Surveillance System avail-  
15 able, as appropriate, to the public, including researchers.

16       “(h) PRIVACY.—The Secretary shall ensure that pri-  
17 vacy and security protections applicable to the National  
18 Neurological Diseases Surveillance System are at least as  
19 stringent as the privacy and security protections under  
20 HIPAA privacy and security law (as defined in section  
21 3009(a)(2)).

22       “(i) REPORT.—Not later than 4 years after the date  
23 of the enactment of this section, the Secretary shall sub-  
24 mit a report to the Congress concerning the implementa-

1 tion of this section. Such report shall include information  
2 on—

3 “(1) the development and maintenance of the  
4 National Neurological Diseases Surveillance System;

5 “(2) the type of information collected and  
6 stored in the System;

7 “(3) the use and availability of such informa-  
8 tion, including guidelines for such use; and

9 “(4) the use and coordination of databases that  
10 collect or maintain information on neurological dis-  
11 eases.

12 “(j) DEFINITION.—In this section, the term ‘national  
13 voluntary health association’ means a national nonprofit  
14 organization with chapters, other affiliated organizations,  
15 or networks in States throughout the United States.

16 “(k) AUTHORIZATION OF APPROPRIATIONS.—To  
17 carry out this section, there is authorized to be appro-  
18 priated \$5,000,000 for each of fiscal years 2012 through  
19 2016.”.
