SECTION 1. SHORT TITLE.

2	This Act	may be	cited as	s the	"DOE	and	USDA	Inter-

- 3 agency Research Act".
- 4 SEC. 2. DEPARTMENT OF ENERGY AND DEPARTMENT OF
- 5 AGRICULTURE JOINT RESEARCH AND DEVEL-
- 6 OPMENT ACTIVITIES.
- 7 (a) IN GENERAL.—The Secretary of Energy and the
- 8 Secretary of Agriculture (in this section referred to as the
- 9 "Secretaries") shall carry out cross-cutting and collabo-
- 10 rative research and development activities focused on the
- 11 joint advancement of Department of Energy and Depart-
- 12 ment of Agriculture mission requirements and priorities.
- 13 (b) Memorandum of Understanding.—The Sec-
- 14 retaries shall carry out and coordinate the activities under
- 15 subsection (a) through the establishment of a memo-
- 16 randum of understanding, or other appropriate inter-
- 17 agency agreement. Such memorandum or agreement shall
- 18 require the use of a competitive, merit-reviewed process,
- 19 which considers applications from Federal agencies, Na-
- 20 tional Laboratories, institutions of higher education, non-
- 21 profit institutions, and other appropriate entities.
- (c) Coordination.—In carrying out the activities
- 23 under subsection (a), the Secretaries may—
- 24 (1) conduct collaborative research over a variety
- of focus areas, such as—

- 1 (A) modeling and simulation, machine
 2 learning, artificial intelligence, data assimila3 tion, large scale data analytics, and predictive
 4 analysis in order to optimize algorithms for
 5 purposes related to agriculture and energy,
 6 such as life cycle analysis of agricultural or energy systems;
 - (B) fundamental agricultural, biological, computational, and environmental science and engineering, including advanced crop science, crop protection, breeding, and biological pest control, in collaboration with the program authorized under section 306 of the Department of Energy Research and Innovation Act (42 U.S.C. 18644);
 - (C) integrated natural resources and the energy-water nexus, including in collaboration with the program authorized under section 1010 of the Energy Act of 2020 (enacted as division Z of the Consolidated Appropriations Act, 2021 (42 U.S.C. 16183));
 - (D) advanced biomass, biobased products, and biofuels, including in collaboration with the activities authorized under section 9008(b) of

2	2002 (7 U.S.C. 8108(b));
3	(E) diverse feedstocks for economically and
4	environmentally sustainable fuels, including
5	aviation and naval fuels;
6	(F) colocation of agricultural resources and
7	activities and ecosystem services with diverse
8	energy technologies and resources, such as geo-
9	thermal energy, nuclear energy, solar energy,
10	wind energy, natural gas, hydropower, and en-
11	ergy storage;
12	(G) colocation of agricultural resources
13	and activities with carbon storage and utiliza-
14	tion technologies;
15	(H) invasive species management to fur-
16	ther the work done by the Federal Interagency
17	Committee for the Management of Noxious and
18	Exotic Weeds;
19	(I) long-term and high-risk technological
20	barriers in the development of transformative
21	science and technology solutions in the agri-
22	culture and energy sectors, including in collabo-
23	ration with the program authorized under sec-
24	tion 5012 of the America COMPETES Act $(42$
25	U.S.C. 16538);

1	(J) grid modernization and grid security;
2	(K) rural technology development, includ-
3	ing manufacturing, precision agriculture tech-
4	nologies, and mechanization and automation
5	technologies; and
6	(L) wildfire risks and prevention, including
7	the power sector's role in fire prevention and
8	mitigation and wildfire impacts on energy infra-
9	structure;
10	(2) develop methods to accommodate large vol-
11	untary standardized and integrated data sets on ag-
12	ricultural, environmental, supply chain, and eco-
13	nomic information with variable accuracy and scale;
14	(3) promote collaboration, open community-
15	based development, and data and information shar-
16	ing between Federal agencies, National Labora-
17	tories, institutions of higher education, nonprofit in-
18	stitutions, industry partners, and other appropriate
19	entities by providing reliable access to secure data
20	and information that are in compliance with Federal
21	rules and regulations;
22	(4) support research infrastructure and work-
23	force development as the Secretaries determine nec-
24	essary; and

1	(5) conduct collaborative research, development,
2	and demonstration of methods and technologies to—
3	(A) improve the efficiency of agriculture
4	operations and processing of agricultural prod-
5	ucts; and
6	(B) reduce greenhouse gas emissions asso-
7	ciated with such operations and such proc-
8	essing.
9	(d) Agreements.—In carrying out the activities
10	under subsection (a), the Secretaries are authorized to—
11	(1) carry out reimbursable agreements between
12	the Department of Energy, the Department of Agri-
13	culture, and other entities in order to maximize the
14	effectiveness of research and development; and
15	(2) collaborate with other Federal agencies as
16	appropriate.
17	(e) Report.—Not later than two years after the date
18	of the enactment of this Act, the Secretaries shall submit
19	to the Committee on Science, Space, and Technology and
20	the Committee on Agriculture of the House of Representa-
21	tives, and the Committee on Energy and Natural Re-
22	sources and the Committee on Agriculture, Nutrition, and
23	Forestry of the Senate a report detailing the following:

1	(1) Interagency coordination between each Fed-
2	eral agency involved in the research and development
3	activities carried out under this section.
4	(2) Potential opportunities to expand the tech-
5	nical capabilities of the Department of Energy and
6	the Department of Agriculture.
7	(3) Collaborative research achievements.
8	(4) Areas of future mutually beneficial suc-
9	cesses.
10	(5) Continuation of coordination activities be-
11	tween the Department of Energy and the Depart-
12	ment of Agriculture.
13	(f) Research Security.—The activities authorized
14	under this section shall be applied in a manner consistent
15	with subtitle D of title VI of the Research and Develop-
16	ment, Competition, and Innovation Act (enacted as divi-
17	sion B of Public Law 117–167; 42 U.S.C. 19231 et seq.).
