A BILL

To amend title 38, United States Code, to make permanent certain programs that assist homeless veterans and other veterans with special needs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Helping Homeless Vet-
5 erans Act of 2019”.

1 **SEC. 2. PROGRAMS ASSISTING HOMELESS VETERANS AND**
2 **OTHER VETERANS WITH SPECIAL NEEDS.**

3 (a) HOMELESS VETERANS REINTEGRATION PRO-
4 GRAMS.—Section 2021(e)(1) of title 38, United States
5 Code, is amended by adding at the end the following:

6 “(G) \$50,000,000 for each fiscal year after
7 2020.”.

8 (b) REFERRAL AND COUNSELING SERVICES FOR
9 VETERANS AT RISK OF HOMELESSNESS WHO ARE
10 TRANSITIONING FROM CERTAIN INSTITUTIONS.—Section
11 2023 of such title is amended—

12 (1) by striking subsection (d); and

13 (2) by redesignating subsection (e) as sub-
14 section (d).

15 (c) TREATMENT FOR SERIOUSLY MENTALLY ILL
16 AND HOMELESS VETERANS.—Section 2031 of such title
17 is amended—

18 (1) in subsection (a), by striking “(a)”; and

19 (2) by striking subsection (b).

20 (d) HOUSING ASSISTANCE FOR HOMELESS VET-
21 ERANS.—Section 2041 of such title is amended by striking
22 subsection (e).

23 (e) FINANCIAL ASSISTANCE FOR SUPPORTIVE SERV-
24 ICES FOR VERY LOW-INCOME VETERAN FAMILIES IN
25 PERMANENT HOUSING.—Section 2044(e)(1) of such title

1 is amended by adding at the end the following new sub-
2 paragraph:

3 “(H) \$380,000,000 for each fiscal year after
4 fiscal year 2019.”.

5 (f) GRANT PROGRAM FOR HOMELESS VETERANS
6 WITH SPECIAL NEEDS.—Section 2061(d)(1) of such title
7 is amended—

8 (1) by striking “each of fiscal years 2007
9 through 2020” and inserting “each fiscal year”; and

10 (2) by striking “such”.

11 (g) ADVISORY COMMITTEE ON HOMELESS VET-
12 ERANS.—Section 2066 of such title is amended by striking
13 subsection (d).
