A BILL

To amend the Federal Power Act to provide for extended periods relating to preliminary permits and commencement of construction, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “HYdropower Permit
5 Extension Act” or the “HYPE Act”.

6 **SEC. 2. EXTENSIONS OF PERIODS.**

7 (a) PRELIMINARY PERMITS.—Section 5 of the Fed-
8 eral Power Act (16 U.S.C. 798) is amended—

9 (1) in subsection (a), by striking “three” and
10 inserting “four”; and

11 (2) in subsection (b)—

12 (A) by striking “Commission may extend
13 the period of a preliminary permit once for not
14 more than 2 additional years beyond the 3
15 years” and inserting the following: “Commis-
16 sion may—

17 “(1) extend the period of a preliminary permit
18 once for not more than four additional years beyond
19 the four years”;

20 (B) by striking the period at the end and
21 inserting “; and”; and

22 (C) by adding at the end the following:

23 “(2) if the period of a preliminary permit is ex-
24 tended under paragraph (1), extend the period of
25 such preliminary permit once for not more than four

1 additional years beyond the extension period granted
2 under paragraph (1), if the Commission determines
3 that there are extraordinary circumstances that war-
4 rant such additional extension.”.

5 (b) TIME LIMIT FOR CONSTRUCTION OF PROJECT
6 WORKS.—Section 13 of the Federal Power Act (16 U.S.C.
7 806) is amended in the second sentence by striking “once
8 but not longer than two additional years” and inserting
9 “for not more than eight additional years,”.
