- To amend the Small Business Act to provide interim partial payment to small business contractors that request an equitable adjustment due to a change in the terms of a construction contract, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Small Business Pay-
- 5 ment for Performance Act of 2019".

3 (a) IN GENERAL.—The Small Business Act (15
4 U.S.C. 631 et seq.) is amended by inserting after section
5 15 the following new section:

6 "SEC. 15A. EQUITABLE ADJUSTMENTS TO CONSTRUCTION 7 CONTRACTS.

8 "(a) Request for an Equitable Adjustment.— A small business concern performing a construction con-9 tract that was awarded by an agency may submit a re-10 11 quest for an equitable adjustment to the contracting officer of such agency if the contracting officer directs a 12 13 change in the terms of the contract performance without the agreement of the small business concern. Such request 14 shall— 15

- 16 "(1) be timely made pursuant to the terms of17 the contract; and
- 18 "(2) specify the estimated amount required to
 19 cover additional costs resulting from such change in
 20 the terms of the contract performance.

"(b) AMOUNT.—Upon receipt of a request for equitable adjustment under subsection (a), the agency shall
provide to the small business concern an interim partial
payment in an amount that is at least 50 percent of the
estimated amount under subsection (a)(2).

1 "(c) LIMITATION.—Any interim partial payment 2 made under this section shall not be deemed to be an ac-3 tion to definitize the request for an equitable adjustment. 4 "(d) FLOW-DOWN OF INTERIM PARTIAL PAYMENT 5 AMOUNTS.—A small business concern that requests an equitable adjustment under this section shall pay to a first 6 7 tier subcontractor or supplier the portion of each interim 8 partial payment received that is attributable to the in-9 creased costs of performance incurred by the first tier sub-10 contractor or supplier due to the change in the terms of the contract performance. A first tier subcontractor or 11 12 supplier that receives a portion of an interim partial pay-13 ment under this section shall pay to a subcontractor or supplier at any tier the appropriate portion of such pay-14 15 ment.".

(b) IMPLEMENTATION.—The Administrator of the
Small Business Administration shall implement the requirements of this section not later than the earlier of the
following dates:

20 (1) The first day of the first full fiscal year be21 ginning after the date of the enactment of this Act.
22 (2) October 1, 2021.
