3 **SECTION 1. BUILDING DESIGNATION.**

4 (a) DESIGNATION.—The Federal building and United
5 States courthouse located at 1300 Victoria Street in La-
6 redo, Texas, shall be known and designated as the
7 “George P. Kazen Federal Building and United States
8 Courthouse”.

9 (b) REFERENCES.—Any reference in a law, map, reg-
10 ulation, document, paper, or other record of the United
11 States to the Federal building and United States court-
12 house referred to in subsection (a) shall be deemed to be
13 a reference to the “George P. Kazen Federal Building and
14 United States Courthouse”.

15 **SEC. 2. JURY ROOM DESIGNATION.**

16 (a) DESIGNATION.—The jury room located in the
17 Federal building and United States courthouse referred
18 to in section 1 shall be known and designated as the
19 “Mareel C. Notzon II Jury Room”.

20 (b) REFERENCES.—Any reference in a law, map, reg-
21 ulation, document, paper, or other record of the United
22 States to the jury room referred to in subsection (a) shall
23 be deemed to be a reference to the “Mareel C. Notzon
24 II Jury Room”.

1 **SEC. 3. EFFECTIVE DATE.**

2 This Act shall take effect on the first day on which
3 George P. Kazen is no longer serving as a Federal judge.

4 **SECTION 1. BUILDING DESIGNATION.**

5 (a) *DESIGNATION.*—*The Federal building and United*
6 *States courthouse located at 1300 Victoria Street in Laredo,*
7 *Texas, shall be known and designated as the “George P.*
8 *Kazen Federal Building and United States Courthouse”.*

9 (b) *REFERENCES.*—*Any reference in a law, map, regu-*
