## A BILL

To amend chapter 301 of title 49, United States Code, to improve access to motor vehicle information, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. IMPROVED ACCESS TO MOTOR VEHICLE INFOR-**  
4 **MATION.**

5 (a) AMENDMENT.—Subchapter II of chapter 301 of  
6 title 49, United States Code, is amended by inserting after  
7 section 30117 the following new section:

1 **“§ 30117A. Motor vehicle information made available**  
2 **to owners and potential purchasers**

3 “(a) MOTOR VEHICLE INFORMATION.—The Sec-  
4 retary of Transportation may require that each manufac-  
5 turer of a motor vehicle provide the following information,  
6 with regard to a specific vehicle identification number:

7 “(1) Each original equipment manufacturer  
8 (OEM) part name included within such vehicle, a de-  
9 scription of each such part, each part number (in-  
10 cluding any superceded and successor OEM part  
11 number), any other part identification number (such  
12 as a serial number) and distinguishing marking of  
13 each such part, and the software of each such part  
14 (if applicable).

15 “(2) Build sheet information.

16 “(3) Additional information as determined by  
17 the Secretary.

18 “(b) INFORMATION MADE AVAILABLE TO OWNERS  
19 AND POTENTIAL PURCHASERS.—

20 “(1) WEBSITE ACCESS.—Each manufacturer of  
21 a motor vehicle shall provide access to the informa-  
22 tion described under subsection (a), in a standard-  
23 ized format, through a website to the owner of the  
24 motor vehicle and any potential purchaser of the  
25 motor vehicle (and to any designated agent of any  
26 such owner or potential purchaser). The website

1 shall also be searchable electronically with batch ac-  
2 cess to the information described under subsection  
3 (a), in a standardized format.

4 “(2) COMPLIANCE.—The Secretary shall deter-  
5 mine and ensure compliance with this paragraph.”.

6 (b) TECHNICAL AND CONFORMING AMENDMENT.—  
7 The table of chapters for chapter 301 of title 49, United  
8 States Code, is amended by inserting after the item relat-  
9 ing to section 30117 the following new item:

“30117A. Motor vehicle information made available to purchaser.”.

10 (c) APPLICABILITY.—The amendment made by sub-  
11 section (a) shall take effect with regard to any motor vehi-  
12 cle sold on or after November 1, 2000.

13 (d) EFFECTIVE DATE.—This Act, and the amend-  
14 ments made by this Act, shall take effect 90 days after  
15 the date of enactment of this Act.
