## A BILL

To prohibit the use of the poisons sodium fluoroacetate (known as “Compound 1080”) and sodium cyanide for predator control.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Chemical Poisons Re-  
5 duction Act of 2019” or the “Canyon’s Law”.

6 **SEC. 2. PURPOSE.**

7 The purpose of this Act is to restrict the use of the  
8 poisons sodium fluoroacetate (known as “Compound

1 1080”) and sodium cyanide to kill predatory animals given  
2 the risks posed by such poisons to—

- 3 (1) public safety;
- 4 (2) national security;
- 5 (3) the environment; and
- 6 (4) persons and other animals that come into  
7 accidental contact with such poisons.

8 **SEC. 3. PROHIBITION ON USE OF CERTAIN POISONS FOR**  
9 **PREDATOR CONTROL.**

10 (a) PROHIBITED ACT.—Sodium fluoroacetate (known  
11 as “Compound 1080”) and sodium cyanide may not be  
12 used in a predator control device.

13 (b) PENALTY.—Whoever uses sodium fluoroacetate  
14 or sodium cyanide in a predator control device shall be  
15 fined under title 18, United States Code, or imprisoned  
16 not more than 2 years, or both.

17 (c) PREDATOR CONTROL DEVICE DEFINED.—In this  
18 section, the term “predator control device” means—

- 19 (1) a dispenser designed to propel sodium  
20 fluoroacetate or sodium cyanide when activated by  
21 an animal;
- 22 (2) a livestock protection collar designed to re-  
23 lease sodium fluoroacetate or sodium cyanide when  
24 punctured by an animal;

1           (3) a gas cartridge or other pyrotechnic device  
2           designed to emit sodium fluoroacetate or sodium cy-  
3           anide fumes; and

4           (4) any other means of dispensing sodium  
5           fluoroacetate or sodium cyanide, including in the  
6           form of capsules, for wildlife management or other  
7           animal control purposes.
