AN ACT

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2012, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 ~~That the following sums are appropriated, out of any~~
4 ~~money in the Treasury not otherwise appropriated, for the~~
5 ~~Legislative Branch for the fiscal year ending September~~
6 ~~30, 2012, and for other purposes, namely:~~

1 TITLE I—LEGISLATIVE BRANCH

2 HOUSE OF REPRESENTATIVES

3 SALARIES AND EXPENSES

4 For salaries and expenses of the House of Represent-
5 atives, \$1,226,680,000 (reduced by \$1,000,000), as fol-
6 lows:

7 HOUSE LEADERSHIP OFFICES

8 For salaries and expenses, as authorized by law,
9 \$23,275,773, including: Office of the Speaker,
10 \$6,942,770, including \$25,000 for official expenses of the
11 Speaker; Office of the Majority Floor Leader, \$2,277,595,
12 including \$10,000 for official expenses of the Majority
13 Leader; Office of the Minority Floor Leader, \$7,432,812,
14 including \$10,000 for official expenses of the Minority
15 Leader; Office of the Majority Whip, including the Chief
16 Deputy Majority Whip, \$1,971,050, including \$5,000 for
17 official expenses of the Majority Whip; Office of the Mi-
18 nority Whip, including the Chief Deputy Minority Whip,
19 \$1,524,951, including \$5,000 for official expenses of the
20 Minority Whip; Republican Conference, \$1,572,788;

21 For salaries and expenses of standing committees,
22 special and select, authorized by House resolutions,
23 \$125,964,870: *Provided*, That such amount shall remain
24 available for such salaries and expenses until December
25 31, 2012.

1 COMMITTEE ON APPROPRIATIONS

2 For salaries and expenses of the Committee on Ap-
3 propriations, ~~\$26,665,785~~, including studies and examina-
4 tions of executive agencies and temporary personal serv-
5 ices for such committee, to be expended in accordance with
6 section 202(b) of the Legislative Reorganization Act of
7 1946 and to be available for reimbursement to agencies
8 for services performed: *Provided*, That such amount shall
9 remain available for such salaries and expenses until De-
10 cember ~~31~~, 2012.

11 SALARIES, OFFICERS AND EMPLOYEES

12 For salaries and expenses of officers and employees,
13 as authorized by law, ~~\$177,628,400~~, including: for salaries
14 and expenses of the Office of the Clerk, including not more
15 than ~~\$23,000~~, of which not more than ~~\$20,000~~ is for the
16 Family Room, for official representation and reception ex-
17 penses, ~~\$26,114,400~~, of which ~~\$2,000,000~~ shall remain
18 available until expended; for salaries and expenses of the
19 Office of the Sergeant at Arms, including the position of
20 Superintendent of Garages and the Office of Emergency
21 Management, and including not more than ~~\$3,000~~ for offi-
22 cial representation and reception expenses, ~~\$12,585,000~~
23 of which ~~\$4,445,000~~ shall remain available until expended;
24 for salaries and expenses of the Office of the Chief Admin-
25 istrative Officer including not more than ~~\$3,000~~ for offi-

1 cial representation and reception expenses, \$116,782,000;
2 of which \$3,937,000 shall remain available until expended;
3 for salaries and expenses of the Office of the Inspector
4 General, \$5,045,000; for salaries and expenses of the Of-
5 fice of General Counsel, \$1,415,000; for the Office of the
6 Chaplain, \$179,000; for salaries and expenses of the Of-
7 fice of the Parliamentarian, including the Parliamen-
8 tarian, \$2,000 for preparing the Digest of Rules, and not
9 more than \$1,000 for official representation and reception
10 expenses, \$2,060,000; for salaries and expenses of the Of-
11 fice of the Law Revision Counsel of the House,
12 \$3,258,000; for salaries and expenses of the Office of the
13 Legislative Counsel of the House, \$8,814,000; for salaries
14 and expenses of the Office of Interparliamentary Affairs,
15 \$859,000; for other authorized employees, \$347,000; and
16 for salaries and expenses of the Historian, \$170,000.

18 For allowances and expenses as authorized by House
19 resolution or law, \$293,386,942 (reduced by \$1,000,000),
20 including: supplies, materials, administrative costs and
21 Federal tort claims, \$3,696,118; official mail for commit-
22 tees, leadership offices, and administrative offices of the
23 House, \$201,000; Government contributions for health,
24 retirement, Social Security, and other applicable employee
25 benefits, \$264,848,219; Business Continuity and Disaster

1 Recovery, \$17,112,072, of which \$5,000,000 shall remain
2 available until expended; transition activities for new
3 members and staff, \$2,721,533 (reduced by \$1,000,000);
4 Wounded Warrior Program \$2,500,000, to remain avail-
5 able until expended; Office of Congressional Ethics,
6 \$1,548,000; and miscellaneous items including purchase,
7 exchange, maintenance, repair and operation of House
8 motor vehicles, interparliamentary receptions, and gratu-
9 ities to heirs of deceased employees of the House,
10 \$760,000.

12 SEC. 101. (a) ~~REQUIRING AMOUNTS REMAINING IN~~
13 ~~MEMBERS' REPRESENTATIONAL ALLOWANCES TO BE~~
14 ~~USED FOR DEFICIT REDUCTION OR TO REDUCE THE~~
15 ~~FEDERAL DEBT.~~—Notwithstanding any other provision of
16 law, any amounts appropriated under this Act for
17 ~~“HOUSE OF REPRESENTATIVES—SALARIES AND~~
18 ~~EXPENSES—MEMBERS' REPRESENTATIONAL ALLOW-~~
19 ~~ANCES”~~ shall be available only for fiscal year 2012. Any
20 amount remaining after all payments are made under such
21 allowances for fiscal year 2012 shall be deposited in the
22 Treasury and used for deficit reduction (or, if there is no
23 Federal budget deficit after all such payments have been
24 made, for reducing the Federal debt, in such manner as
25 the Secretary of the Treasury considers appropriate).

1 (b) REGULATIONS.—The Committee on House Ad-
 2 ministration of the House of Representatives shall have
 3 authority to prescribe regulations to carry out this section.

4 (c) DEFINITION.—As used in this section, the term
 5 “Member of the House of Representatives” means a Rep-
 6 resentative in, or a Delegate or Resident Commissioner
 7 to, the Congress.

9 SEC. 102. (a) Section 109(a) of the Legislative
 10 Branch Appropriations Act, 2005 (2 U.S.C. 74a-13(a))
 11 is amended by striking “the chair of the Republican Con-
 12 ference” and inserting the following: “the Speaker of the
 13 House of Representatives (or, if the Speaker is not a mem-
 14 ber of the Republican Party, the Minority Leader of the
 15 House of Representatives)”.

16 (b) Section 109(b) of such Act (2 U.S.C. 74a-13(b))
 17 is amended by striking the period at the end and inserting
 18 the following: “, and which shall be obligated and ex-
 19 pended as directed by the Speaker (or, if the Speaker is

4 SEC. 103. (a) AUTHORITY OF SPEAKER.—

5 (1) AUTHORITY DESCRIBED.—Notwithstanding
6 any other provision of law (including any provision
7 of law that sets forth an allowance for official ex-
8 penses), the amount appropriated or otherwise made
9 available during a Congress for the salaries and ex-
10 penses of any office or authority described in para-
11 graph (2) shall be the amount allocated for such of-
12 fice or authority by the Speaker of the House of
13 Representatives from the aggregate amount appro-
14 priated or otherwise made available for all such of-
15 fices and authorities.

16 (2) OFFICES AND AUTHORITIES DESCRIBED.—

14 terms and conditions as the Minority Leader of the
15 House of Representatives may direct);”; and

16 (3) in paragraph (2), by striking “direct.” and
17 inserting the following: “direct (or, if the Speaker is
18 a member of the Democratic Party, under such
19 terms and conditions as the Speaker may direct).”.

1 OFFICE OF THE ATTENDING PHYSICIAN

2 For medical supplies, equipment, and contingent ex-
3 penses of the emergency rooms, and for the Attending
4 Physician and his assistants, including: (1) an allowance
5 of \$2,175 per month to the Attending Physician; (2) an
6 allowance of \$1,300 per month to the Senior Medical Offi-
7 cer; (3) an allowance of \$725 per month each to three

22 SALARIES AND EXPENSES

23 For salaries and expenses of the Office of Congres-
24 sional Accessibility Services, \$1,363,000, to be disbursed
25 by the Secretary of the Senate.

1 CAPITOL POLICE

2 SALARIES

3 For salaries of employees of the Capitol Police, in-
4 cluding overtime, hazardous duty pay, and Government
5 contributions for health, retirement, social security, pro-
6 fessional liability insurance, and other applicable employee
7 benefits, ~~\$277,132,624~~ (increased by \$1,000,000), to be
8 disbursed by the Chief of the Capitol Police or his des-
9 ignee.

10 GENERAL EXPENSES

11 For necessary expenses of the Capitol Police, includ-
12 ing motor vehicles, communications and other equipment,
13 security equipment and installation, uniforms, weapons,
14 supplies, materials, training, medical services, forensic
15 services, stenographic services, personal and professional
16 services, the employee assistance program, the awards pro-
17 gram, postage, communication services, travel advances,
18 relocation of instructor and liaison personnel for the Fed-
19 eral Law Enforcement Training Center, and not more
20 than \$5,000 to be expended on the certification of the
21 Chief of the Capitol Police in connection with official rep-
22 resentation and reception expenses, ~~\$63,003,740~~, of which
23 \$2,000,000 shall remain available until September 30,
24 2014, to be disbursed by the Chief of the Capitol Police
25 or his designee: *Provided*, That, notwithstanding any other

1 provision of law, the cost of basic training for the Capitol
2 Police at the Federal Law Enforcement Training Center
3 for fiscal year 2012 shall be paid by the Secretary of
4 Homeland Security from funds available to the Depart-
5 ment of Homeland Security.

6 ADMINISTRATIVE PROVISIONS

7 (INCLUDING TRANSFER OF FUNDS)

8 SEC. 1001. Amounts appropriated for fiscal year
9 2012 for the Capitol Police may be transferred between
10 the headings “Salaries” and “General Expenses” upon the
11 approval of the Committees on Appropriations of the
12 House of Representatives and the Senate.

13 WAIVER BY CHIEF OF CAPITOL POLICE OF CLAIMS
14 ARISING OUT OF ERRONEOUS PAYMENTS TO OFFI-
15 CERS AND EMPLOYEES

16 SEC. 1002. (a) WAIVER OF CLAIM.—Subject to the
17 approval of the Capitol Police Board, the Chief of the
18 United States Capitol Police may waive in whole or in part
19 a claim of the United States against a person arising out
20 of an erroneous payment of any pay or allowances, other
21 than travel and transportation expenses and allowances,
22 to an officer, member, or employee of the United States
23 Capitol Police, if the collection of the claim would be
24 against equity and good conscience and not in the best
25 interests of the United States.

1 (b) INVESTIGATION OF APPLICATION; REPORT.—The
2 Chief shall investigate each application for the waiver of
3 a claim under subsection (a) and shall submit a written
4 report of the investigation to the Capitol Police Board, ex-
5 cept that if the aggregate amount of the claim involved
6 exceeds \$1,500, the Comptroller General may also inves-
7 tigate the application and submit a written report of the
8 investigation to the Capitol Police Board.

9 (c) PROHIBITION OF WAIVER UNDER CERTAIN CIR-
10 CUMSTANCES.—The Chief may not exercise the authority
11 to waive a claim under subsection (a) if—

12 (1) in the Chief's opinion, there exists in con-
13 nection with the claim an indication of fraud, mis-
14 representation, fault, or lack of good faith on the
15 part of the officer, member, or employee involved or
16 of any other person having an interest in obtaining
17 a waiver of the claim; or

18 (2) the Chief receives the application for the
19 waiver after the expiration of the 3-year period that
20 begins on the date on which the erroneous payment
21 of pay or allowances was discovered.

22 (d) CREDIT FOR WAIVER.—In the audit and settle-
23 ment of accounts of any accountable officer or official, full
24 credit shall be given for any amounts with respect to which

1 collection by the United States is waived under subsection
2 (a).

3 (e) EFFECT OF WAIVER.—An erroneous payment,
4 the collection of which is waived under subsection (a), is
5 deemed a valid payment for all purposes.

6 (f) CONSTRUCTION WITH OTHER LAWS.—This sec-
7 tion does not affect any authority under any other law
8 to litigate, settle, compromise, or waive any claim of the
9 United States.

10 (g) RULES AND REGULATIONS.—The Chief shall pro-
11 mulgate rules and regulations to carry out this section.

12 (h) EFFECTIVE DATE.—This section shall apply with
13 respect to payments of pay and allowances made at any
14 time after the Chief became the disbursing officer for the
15 United States Capitol Police pursuant to section 1018(a)
16 of the Legislative Branch Appropriations Act, 2003 (2
17 U.S.C. 1907(a)).

18 OFFICE OF COMPLIANCE

19 SALARIES AND EXPENSES

20 For salaries and expenses of the Office of Compli-
21 ance, as authorized by section 305 of the Congressional
22 Accountability Act of 1995 (2 U.S.C. 1385), \$3,817,000,
23 of which \$884,000 shall remain available until September
24 30, 2013: *Provided*, That not more than \$500 may be ex-
25 pended on the certification of the Executive Director of

1 the Office of Compliance in connection with official rep-
2 resentation and reception expenses.

3 CONGRESSIONAL BUDGET OFFICE

4 SALARIES AND EXPENSES

5 For salaries and expenses necessary for operation of
6 the Congressional Budget Office, including not more than
7 \$6,000 to be expended on the certification of the Director
8 of the Congressional Budget Office in connection with offi-
9 cial representation and reception expenses, \$43,787,000.

10 ARCHITECT OF THE CAPITOL

11 GENERAL ADMINISTRATION

12 For salaries for the Architect of the Capitol, and
13 other personal services, at rates of pay provided by law;
14 for surveys and studies in connection with activities under
15 the care of the Architect of the Capitol; for all necessary
16 expenses for the general and administrative support of the
17 operations under the Architect of the Capitol including the
18 Botanic Garden; electrical substations of the Capitol, Sen-
19 ate and House office buildings, and other facilities under
20 the jurisdiction of the Architect of the Capitol; including
21 furnishings and office equipment; including not more than
22 \$5,000 for official reception and representation expenses;
23 to be expended as the Architect of the Capitol may ap-
24 prove; for purchase or exchange, maintenance, and oper-
25 ation of a passenger motor vehicle, \$104,790,000, of

1 which \$3,199,000 shall remain available until September
2 30, 2016.

3 CAPITOL BUILDING

4 For all necessary expenses for the maintenance, care
5 and operation of the Capitol, \$35,354,000, of which
6 \$10,263,000 shall remain available until September 30,
7 2016.

8 CAPITOL GROUNDS

9 For all necessary expenses for care and improvement
10 of grounds surrounding the Capitol, the Senate and House
11 office buildings, and the Capitol Power Plant, \$9,852,000.

12 HOUSE OFFICE BUILDINGS

13 For all necessary expenses for the maintenance, care
14 and operation of the House office buildings, \$89,154,000,
15 of which \$40,631,000 shall remain available until Sep-
16 tember 30, 2016.

17 In addition, for a payment to the House Historic
18 Buildings Revitalization Trust Fund, \$30,000,000, shall
19 remain available until expended.

20 CAPITOL POWER PLANT

21 For all necessary expenses for the maintenance, care
22 and operation of the Capitol Power Plant, lighting, heat-
23 ing, power (including the purchase of electrical energy)
24 and water and sewer services for the Capitol, Senate and
25 House office buildings, Library of Congress buildings, and

1 the grounds about the same, Botanic Garden, Senate ga-
2 rage, and air conditioning refrigeration not supplied from
3 plants in any of such buildings; heating the Government
4 Printing Office and Washington City Post Office, and
5 heating and chilled water for air conditioning for the Su-
6 preme Court Building; the Union Station complex; the
7 Thurgood Marshall Federal Judiciary Building and the
8 Folger Shakespeare Library, expenses for which shall be
9 advanced or reimbursed upon request of the Architect of
10 the Capitol and amounts so received shall be deposited
11 into the Treasury to the credit of this appropriation,
12 \$127,159,000, of which \$33,377,000 shall remain avail-
13 able until September 30, 2016: *Provided*, That not more
14 than \$9,000,000 of the funds credited or to be reimbursed
15 to this appropriation as herein provided shall be available
16 for obligation during fiscal year 2012.

17 LIBRARY BUILDINGS AND GROUNDS

18 For all necessary expenses for the mechanical and
19 structural maintenance, care and operation of the Library
20 buildings and grounds, \$38,486,000, of which
21 \$12,726,000 shall remain available until September 30,
22 2016.

23 CAPITOL POLICE BUILDINGS, GROUNDS AND SECURITY

24 For all necessary expenses for the maintenance, care
25 and operation of buildings, grounds and security enhance-

1 ments of the United States Capitol Police, wherever lo-
2 cated, the Alternate Computer Facility, and AOC security
3 operations, \$21,500,000, of which \$3,473,000 shall re-
4 main available until September 30, 2016.

5 BOTANIC GARDEN

6 For all necessary expenses for the maintenance, care
7 and operation of the Botanic Garden and the nurseries,
8 buildings, grounds, and collections; and purchase and ex-
9 change, maintenance, repair, and operation of a passenger
10 motor vehicle; all under the direction of the Joint Com-
11 mittee on the Library, \$12,000,000 (reduced by
12 \$632,780): *Provided*, That of the amount made available
13 under this heading, the Architect may obligate and expend
14 such sums as may be necessary for the maintenance, care
15 and operation of the National Garden established under
16 section 307E of the Legislative Branch Appropriations
17 Act, 1989 (2 U.S.C. 2146), upon vouchers approved by
18 the Architect or a duly authorized designee.

19 CAPITOL VISITOR CENTER

20 For all necessary expenses for the operation of the
21 Capitol Visitor Center, \$21,276,000.

22 LIBRARY OF CONGRESS

23 SALARIES AND EXPENSES

24 For all necessary expenses of the Library of Congress
25 not otherwise provided for, including development and

1 maintenance of the Library's catalogs; custody and custo-
2 dial care of the Library buildings; special clothing; clean-
3 ing; laundering and repair of uniforms; preservation of
4 motion pictures in the custody of the Library; operation
5 and maintenance of the American Folklife Center in the
6 Library; activities under the Civil Rights History Project
7 Act of 2009; preparation and distribution of catalog
8 records and other publications of the Library; hire or pur-
9 chase of one passenger motor vehicle; and expenses of the
10 Library of Congress Trust Fund Board not properly
11 chargeable to the income of any trust fund held by the
12 Board, \$412,446,000 (increased by \$1,000,000) (reduced
13 by \$1,000,000), of which not more than \$6,000,000 shall
14 be derived from collections credited to this appropriation
15 during fiscal year 2012; and shall remain available until
16 expended, under the Act of June 28, 1902 (chapter 1301;
17 32 Stat. 480; 2 U.S.C. 150) and not more than \$350,000
18 shall be derived from collections during fiscal year 2012
19 and shall remain available until expended for the develop-
20 ment and maintenance of an international legal informa-
21 tion database and activities related thereto: *Provided,*
22 That the Library of Congress may not obligate or expend
23 any funds derived from collections under the Act of June
24 28, 1902, in excess of the amount authorized for obliga-
25 tion or expenditure in appropriations Acts: *Provided fur-*

1 *ther*, That the total amount available for obligation shall
2 be reduced by the amount by which collections are less
3 than \$6,350,000: *Provided further*, That of the total
4 amount appropriated, not more than \$12,000 may be ex-
5 pended, on the certification of the Librarian of Congress,
6 in connection with official representation and reception ex-
7 penses for the Overseas Field Offices: *Provided further*,
8 That of the total amount appropriated, \$4,800,000 shall
9 remain available until expended for the digital collections
10 and educational curricula program.

18 *vided*, That not more than \$3,000,000 shall be derived
19 from prior year available unobligated balances: *Provided*
20 *further*, That the Copyright Office may not obligate or ex-

23 expenditure in appropriations Acts: *Provided further*, That
24 not more than \$5,484,000 shall be derived from collections

3 For all necessary expenses to carry out the provisions
4 of section 203 of the Legislative Reorganization Act of
5 1946 (2 U.S.C. 166) and to revise and extend the Anno-
6 tated Constitution of the United States of America,
7 \$104,091,000: *Provided*, That no part of such amount
8 may be used to pay any salary or expense in connection
9 with any publication, or preparation of material therefor
10 (except the Digest of Public General Bills), to be issued
11 by the Library of Congress unless such publication has
12 obtained prior approval of either the Committee on House
13 Administration of the House of Representatives or the

(c) TRANSFER OF FUNDS.—During fiscal year 2012, the Librarian of Congress may temporarily transfer funds appropriated in this Act, under the heading “Library of Congress”, under the subheading “Salaries and Expenses”, to the revolving fund for the FEDLINK Program and the Federal Research Program established under section 103 of the Library of Congress Fiscal Operations Improvement Act of 2000 (Public Law 106–481; 2 U.S.C. 182e): *Provided*, That the total amount of such transfers may not exceed \$1,900,000: *Provided further*, That the appropriate revolving fund account shall reimburse the Library for any amounts transferred to it before the period of availability of the Library appropriation expires.

TRANSFER AUTHORITY

2 SEC. 1102. (a) IN GENERAL.—Amounts appropriated
3 for fiscal year 2012 for the Library of Congress may be
4 transferred during fiscal year 2012 between any of the

3 and 2011 to depository and other designated libraries:
4 *Provided further*, That any unobligated or unexpended bal-
5 ances in this account or accounts for similar purposes for

11 GOVERNMENT PRINTING OFFICE REVOLVING FUND

12 The Government Printing Office is hereby authorized
13 to make such expenditures, within the limits of funds
14 available and in accordance with law, and to make such
15 contracts and commitments without regard to fiscal year
16 limitations as provided by section 9104 of title 31, United
17 States Code, as may be necessary in carrying out the pro-
18 grams and purposes set forth in the budget for the current
19 fiscal year for the Government Printing Office revolving
20 fund: *Provided*, That not more than \$7,500 may be ex-

23 may be provided under regulations relating to parking fa-
24 cilities for the House of Representatives issued by the

1 Committee on House Administration and for the Senate
2 issued by the Committee on Rules and Administration.

3 FISCAL YEAR LIMITATION

4 SEC. 202. No part of the funds appropriated in this
5 Act shall remain available for obligation beyond fiscal year
6 2012 unless expressly so provided in this Act.

7 RATES OF COMPENSATION AND DESIGNATION

8 SEC. 203. Whenever in this Act any office or position
9 not specifically established by the Legislative Pay Act of
10 1929 (46 Stat. 32 et seq.) is appropriated for or the rate
11 of compensation or designation of any office or position
12 appropriated for is different from that specifically estab-
13 lished by such Act, the rate of compensation and the des-
14 ignation in this Act shall be the permanent law with re-
15 spect thereto: *Provided*, That the provisions in this Act
16 for the various items of official expenses of Members, offi-
17 cers, and committees of the House of Representatives and
18 Senate, and clerk hire for Senators and Members of the
19 House of Representatives shall be the permanent law with
20 respect thereto.

21 CONSULTING SERVICES

22 SEC. 204. The expenditure of any appropriation
23 under this Act for any consulting service through procure-
24 ment contract, under section 3109 of title 5, United States

1 penditures are a matter of public record and available for
2 public inspection, except where otherwise provided under
3 existing law, or under existing Executive order issued
4 under existing law.

5 AWARDS AND SETTLEMENTS

6 SEC. 205. Such sums as may be necessary are appro-
7 priated to the account described in subsection (a) of sec-
8 tion 415 of the Congressional Accountability Act of 1995
9 (2 U.S.C. 1415(a)) to pay awards and settlements as au-
10 thorized under such subsection.

11 COSTS OF LBFMC

12 SEC. 206. Amounts available for administrative ex-
13 penses of any legislative branch entity which participates
14 in the Legislative Branch Financial Managers Council
15 (LBFMC) established by charter on March 26, 1996, shall
16 be available to finance an appropriate share of LBFMC
17 costs as determined by the LBFMC, except that the total
18 LBFMC costs to be shared among all participating legisla-
19 tive branch entities (in such allocations among the entities
20 as the entities may determine) may not exceed \$2,000.

21 LANDSCAPE MAINTENANCE

22 SEC. 207. The Architect of the Capitol, in consulta-
23 tion with the District of Columbia, is authorized to main-
24 tain and improve the landscape features, excluding streets,
25 in the irregular shaped grassy areas bounded by Wash-

1 ington Avenue, SW on the northeast, Second Street SW
2 on the west, Square 582 on the south, and the beginning
3 of the I-395 tunnel on the southeast.

4 LIMITATION ON TRANSFERS

5 SEC. 208. None of the funds made available in this
6 Act may be transferred to any department, agency, or in-
7 strumentality of the United States Government, except
8 pursuant to a transfer made by, or transfer authority pro-
9 vided in, this Act or any other appropriation Act.

10 GUIDED TOURS OF THE CAPITOL

11 SEC. 209. (a) Except as provided in subsection (b),
12 none of the funds made available to the Architect of the
13 Capitol in this Act may be used to eliminate or restrict
14 guided tours of the United States Capitol which are led
15 by employees and interns of offices of Members of Con-
16 gress and other offices of the House of Representatives
17 and Senate.

18 (b) At the direction of the Capitol Police Board, or
19 at the direction of the Architect of the Capitol with the
20 approval of the Capitol Police Board, guided tours of the
21 United States Capitol which are led by employees and in-
22 terns described in subsection (a) may be suspended tempo-
23 rarily or otherwise subject to restriction for security or re-
24 lated reasons to the same extent as guided tours of the

1 United States Capitol which are led by the Architect of
2 the Capitol.

3 SPENDING REDUCTION ACCOUNT

4 SEC. 210. The amount by which the applicable alloca-
5 tion of new budget authority made by the Committee on

9 budget authority is \$0 (increased by \$632,780) (increased
10 by \$4,946,140.80).

11 SEC. 211. None of the funds made available in this
12 Act may be used to deliver a printed copy of a bill, joint
13 resolution, or resolution to the office of a Member of the
14 House of Representatives (including a Delegate or Resi-
15 dent Commissioner to the Congress) unless the Member
16 requests a copy.

17 SEC. 212. None of the funds made available by this
18 Act may be used to deliver a printed copy of any version
19 of the Congressional Record to the office of a Member of
20 the House of Representatives (including a Delegate or
21 Resident Commissioner to the Congress).

22 SEC. 213. None of the funds made available in this
23 Act may be used by the Chief Administrative Officer of
24 the House of Representatives to make any payments from
25 any Members' Representational Allowance for the leasing

1 of a vehicle in an aggregate amount that exceeds \$1,000
 2 for the vehicle in any month.

3 This Act may be cited as the “Legislative Branch Ap-
 4 propriations Act, 2012”.

11 *LANDSCAPE MAINTENANCE*

12 *SEC. 207. The Architect of the Capitol, in consultation*
13 *with the District of Columbia, is authorized to maintain*
14 *and improve the landscape features, excluding streets, in*
15 *the irregular shaped grassy areas bounded by Washington*
16 *Avenue, SW, on the northeast, Second Street, SW, on the*
17 *west, Square 582 on the south, and the beginning of the*
18 *I-395 tunnel on the southeast.*

19 *LIMITATION ON TRANSFERS*

20 *SEC. 208. None of the funds made available in this*
21 *Act may be transferred to any department, agency, or in-*
22 *strumentality of the United States Government, except pur-*
23 *suant to a transfer made by, or transfer authority provided*
24 *in, this Act or any other appropriation Act.*

1 *GUIDED TOURS OF THE CAPITOL*

2 *SEC. 209. (a) Except as provided in subsection (b),*
3 *none of the funds made available to the Architect of the Cap-*
4 *itol in this Act may be used to eliminate or restrict guided*
5 *tours of the United States Capitol which are led by employ-*
6 *ees and interns of offices of Members of Congress and other*
7 *offices of the House of Representatives and Senate.*

8 *(b) At the direction of the Capitol Police Board, or*
9 *at the direction of the Architect of the Capitol with the ap-*
10 *proval of the Capitol Police Board, guided tours of the*
11 *United States Capitol which are led by employees and in-*
12 *terns described in subsection (a) may be suspended tempo-*
13 *rarily or otherwise subject to restriction for security or re-*
14 *lated reasons to the same extent as guided tours of the*
15 *United States Capitol which are led by the Architect of the*
16 *Capitol.*

17 *(RESCISSION)*

18 *SEC. 210. Of the unobligated balances available from*
19 *prior year appropriations under the heading “Architect of*
20 *the Capitol”\$17,482,000 are hereby rescinded.*

21 *This Act may be cited as the “Legislative Branch Ap-*
22 *propriations Act, 2012”.*
