# **A BILL**

To require the Secretary of Commerce to establish the Sea Turtle Rescue Assistance Grant Program, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Sea Turtle Rescue As-*  
5 *sistance and Rehabilitation Act of 2023”.*

6 **SEC. 2. SEA TURTLE RESCUE ASSISTANCE AND REHABILITATION GRANT PROGRAM.**

8        (a) *ESTABLISHMENT.*—*The Secretary shall establish a*  
9 *grant program, to be known as the “Sea Turtle Rescue As-*  
10 *sistance and Rehabilitation Grant Program”, to encourage*  
11 *and facilitate coordinated rapid response and rescue by*  
12 *awarding grants for the purposes described in subsection*  
13 *(c).*

14        (b) *DESIGNATION OF STRANDING AND REHABILITATION REGIONS.*—*The Secretary shall designate geographic*  
15 *regions of the United States as stranding and rehabilitation*  
16 *regions for the purposes of carrying out this section.*

18        (c) *PURPOSES.*—*The purposes of the Program are to*  
19 *provide for—*

20            (1) *the recovery, short- or long-term care, trans-*  
21 *portation, and treatment of stranded marine turtles;*

22            (2) *the release of rescued and recovered marine*  
23 *turtles;*

1           (3) *the collection of data and samples from*  
2           *stranded marine turtles for scientific research related*  
3           *to marine turtle health; and*

4           (4) *facility operation costs that are directly re-*  
5           *lated to activities described in paragraphs (1), (2),*  
6           *and (3).*

7           (d) *EQUITABLE DISTRIBUTION OF FUNDS.—The Sec-*  
8           *retary shall ensure, to the extent practicable, that funds*  
9           *awarded under this section are distributed equitably among*  
10          *stranding and rehabilitation regions, taking into account—*

11           (1) *the number of stranding and rehabilitation*  
12          *events that occurred in each stranding and rehabilita-*  
13          *tion region in the preceding 5 years; and*

14           (2) *the conservation priorities and recovery needs*  
15          *of species of marine turtles that are threatened or en-*  
16          *dangered under the Endangered Species Act of 1973*  
17          *(16 U.S.C. 1531 et seq.).*

18           (e) *APPLICATION.—An applicant for a grant under*  
19          *this section shall submit an application in such form and*  
20          *manner as the Secretary shall prescribe.*

21           (f) *GRANT CRITERIA.—*

22           (1) *DEVELOPMENT OF CRITERIA.—The Secretary*  
23          *shall, in consultation with the Director of the United*  
24          *States Fish and Wildlife Service, establish by regula-*

1        *tion appropriate criteria for awarding grants under*  
2        *this section.*

3            (2) *STAKEHOLDER ENGAGEMENT.*—*As part of*  
4        *the process for developing and finalizing criteria*  
5        *under paragraph (1), the Secretary shall, in consulta-*  
6        *tion with the Director of the United States Fish and*  
7        *Wildlife Service, provide opportunities for engagement*  
8        *with representatives from stranding and rehabilita-*  
9        *tion regions and representatives of State governments*  
10       *and public and private organizations with an estab-*  
11       *lished record in coordination, rescue, rehabilitation,*  
12       *and release, as well as related scientific research, ma-*  
13       *rine conservation, and forensic science, with respect to*  
14       *stranded marine turtles.*

15           (3) *REQUIRED CRITERIA.*—*The criteria devel-*  
16       *oped under paragraph (1) shall prioritize applicants*  
17       *with an established record of coordination, rescuing,*  
18       *rehabilitation, scientific research, and forensic science*  
19       *with respect to stranded and rehabilitated marine*  
20       *turtles or conducting scientific research and forensic*  
21       *science on stranded and rehabilitated marine turtles.*

22        (g) *LIMITATIONS.*—

23           (1) *MAXIMUM AMOUNT OF GRANT.*—*No grant*  
24       *awarded under this section may exceed \$150,000 in*  
25       *any 12-month period.*

1           (2) *MATCHING REQUIREMENT.*—*The non-Federal*  
2 *share of the costs of an activity conducted with a*  
3 *grant awarded under the Program shall be not less*  
4 *than 50 percent of such costs, including in-kind serv-*  
5 *ices and the use of property.*

6           (h) *DEFINITIONS.*—*In this section:*

7           (1) *MARINE TURTLE.*—*The term “marine turtle”*  
8 *means any member of the family Cheloniidae or*  
9 *Dermochelyidae.*

10          (2) *PROGRAM.*—*The term “Program” means the*  
11 *Sea Turtle Rescue Assistance and Rehabilitation*  
12 *Grant Program established under subsection (a).*

13          (3) *SECRETARY.*—*The term “Secretary” means*  
14 *the Secretary of Commerce.*

15          (4) *STRANDING.*—*The term “stranding” means*  
16 *an event in which—*

17               (A) *a marine turtle is dead and is—*

18                       (i) *on a beach or shore of the United*  
19 *States; or*

20                       (ii) *in waters under the jurisdiction of*  
21 *the United States (including any navigable*  
22 *waters); or*

23               (B) *a marine turtle is alive and is—*

24                       (i) *on a beach or shore of the United*  
25 *States and unable to return to the water;*

1                   (ii) on a beach or shore of the United  
2                   States and in need of medical attention; or  
3                   (iii) in waters under the jurisdiction of  
4                   the United States (including any navigable  
5                   waters), and in need of medical attention or  
6                   other necessary intervention to aid its likeli-  
7                   hood of survival.

8                   (5) *STRANDING AND REHABILITATION REGION.*—  
9                   The term “stranding and rehabilitation region”  
10                  means a geographic region designated by the Sec-  
11                  retary under subsection (b).
