## A BILL

To establish a national task force to expand opportunities and improve the standard of living for working families in America.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Working Families  
5 Task Force Act of 2023”.

6 **SEC. 2. INTERAGENCY TASK FORCE.**

7 (a) ESTABLISHMENT.—Not later than 90 days after  
8 the date of the enactment of this Act, the Secretary of

1 Labor, in consultation with the Secretaries of Health and  
2 Human Services, Education, Housing and Urban Develop-  
3 ment, Commerce, the Treasury, Transportation, and Agri-  
4 culture, shall establish an Interagency National Task  
5 Force on Working Families (in this Act referred to as the  
6 “Task Force”).

7 (b) MEMBERSHIP.—The Task Force shall be com-  
8 posed of not fewer than 10 members and shall include rep-  
9 resentatives designated by the relevant Secretaries from  
10 each of the following Federal agencies:

11 (1) The Department of Labor.

12 (2) The Department of Health and Human  
13 Services.

14 (3) The Department of Education.

15 (4) The Department of Housing and Urban De-  
16 velopment.

17 (5) The Department of Commerce.

18 (6) The Department of the Treasury.

19 (7) The Department of Transportation.

20 (8) The Department of Agriculture.

21 (c) MEETINGS.—

22 (1) IN GENERAL.—The Task Force shall meet  
23 not less than 1 time per quarter per calendar year.

24 (2) QUORUM.—Two-thirds of the members of  
25 the Task Force shall constitute a quorum.

1 (d) PURPOSE.—The purpose of the Task Force shall  
2 be to—

3 (1) examine the challenges facing working fami-  
4 lies; and

5 (2) issue recommendations to improve the  
6 standard of living and quality of life for working  
7 families.

8 (e) DUTIES.—The duties of the Task Force shall in-  
9 clude the following:

10 (1) Identifying and evaluating key factors that  
11 impact the standard of living and quality of life for  
12 working families, including—

13 (A) addressing affordability challenges re-  
14 lated to various economic conditions, including  
15 inflation;

16 (B) improving access to quality jobs with  
17 livable wages and strong labor standards;

18 (C) expanding affordable child care for all  
19 families;

20 (D) improving incentives, including tax  
21 policies such as the child tax credit and earned  
22 income tax credit, that assist children and fami-  
23 lies;

24 (E) supporting home care and medical care  
25 for seniors and families that need assistance;

- 1 (F) accessing quality, affordable housing;  
2 (G) reducing barriers to economic mobility;  
3 (H) expanding educational and workforce  
4 training opportunities; and  
5 (I) increasing financial literacy and access  
6 to financial services.

7 (2) Assessing the effectiveness of current Fed-  
8 eral policies and programs in helping working fami-  
9 lies achieve an improved standard of living and qual-  
10 ity of life.

11 (3) Developing policy recommendations to en-  
12 hance the efforts of Federal agencies and Congress  
13 to empower working families to meet the challenges  
14 of current economic conditions, raise their standards  
15 of living, and access the benefits of economic growth.

16 (f) REPORT.—Not later than 180 days after the date  
17 of the enactment of this Act, and annually thereafter, the  
18 Task Force shall submit to the appropriate congressional  
19 committees a report on its most recent findings and rec-  
20 ommendations.

21 (g) APPROPRIATE CONGRESSIONAL COMMITTEES  
22 DEFINED.—In this section, the term “appropriate con-  
23 gressional committees” means each of the following:

24 (1) The Committee on Education and the  
25 Workforce of the House of Representatives, and the

1 Committee on Health, Education, Labor, and Pen-  
2 sions of the Senate.

3 (2) The Committee on Transportation and In-  
4 frastructure of the House of Representatives, and  
5 the Committee on Commerce, Science, and Trans-  
6 portation of the Senate.

7 (3) The Committee on Financial Services of the  
8 House of Representatives, and the Committee on Fi-  
9 nance of the Senate.

10 (4) The Committee on Energy and Commerce  
11 of the House of Representatives, and the Committee  
12 on Energy and Natural Resources of the Senate.

13 (5) The Committee on Agriculture of the House  
14 of Representatives, and the Committee on Agri-  
15 culture, Nutrition, and Forestry of the Senate.
