## 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Medicare Access to3 Rural Anesthesiology Act of 2019".

4 SEC. 2. MEDICARE PART A PAYMENT FOR ANESTHESIOL5 OGIST SERVICES IN CERTAIN RURAL HOS6 PITALS BASED ON CRNA PASS-THROUGH
7 RULES.

8 (a) IN GENERAL.—Section 1814 of the Social Secu9 rity Act (42 U.S.C. 1395f) is amended by adding at the
10 end the following new subsection:

11 "Anesthesiologist Services Provided in Certain Rural
12 Hospitals

"(m)(1) Notwithstanding any other provision of this 13 title, coverage and payment shall be provided under this 14 part for physicians' services that are anesthesia services 15 16 furnished by a physician who is an anesthesiologist in a 17 rural hospital described in paragraph (3) in the same 18 manner as payment is made under the exception provided 19 in section 9320(k) of the Omnibus Budget Reconciliation 20 Act of 1986, as amended by section 6132 of the Omnibus 21 Budget Reconciliation Act of 1989 (42 U.S.C. 1395k 22 note) (relating to payment on a reasonable cost, pass-23 through basis), for certified registered nurse anesthetist 24 services furnished by a certified registered nurse anesthetist in a hospital described in such section. 25

"(2) No payment shall be made under any other pro vision of this title for physicians' services for which pay ment is made under this subsection.

4 "(3) A rural hospital described in this paragraph is
5 a hospital described in section 9320(k) of the Omnibus
6 Budget Reconciliation Act of 1986, as so amended (42
7 U.S.C. 1395k note), except that—

8 "(A) any reference in such section to a 'cer-9 tified registered nurse anesthetist' or 'anesthetist' is 10 deemed a reference to a 'physician who is an anes-11 thesiologist' or 'anesthesiologist', respectively; and

"(B) any reference to 'January 1, 1988' or
'1987' is deemed a reference to such date and year
as the Secretary shall specify.".

(b) EFFECTIVE DATE.—The amendment made by
subsection (a) shall apply to services furnished during cost
reporting periods beginning on or after the date of the
enactment of this Act.
