A BILL

To require the Secretary of Homeland Security to submit a study on the circumstances which may impact the effectiveness and availability of first responders before, during, or after a terrorist threat or event, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “First Responder Iden-
5 tification of Emergency Needs in Disaster Situations Act”
6 or the “FRIENDS Act”.

1 **SEC. 2. CIRCUMSTANCES WHICH MAY IMPACT FIRST RE-**
2 **SPONDERS DURING A TERRORIST EVENT.**

3 (a) IN GENERAL.—Not later than one year after the
4 date of the enactment of this Act, the Comptroller General
5 of the United States shall submit to the Committees on
6 Homeland Security and Transportation and Infrastruc-
7 ture of the House of Representatives and the Committee
8 on Homeland Security and Governmental Affairs of the
9 Senate a report that describes select State and local pro-
10 grams and policies, as appropriate, related to the pre-
11 paredness and protection of first responders. The report
12 may include information on the following:

13 (1) The degree to which such programs and
14 policies include consideration of the presence of a
15 first responder’s family in an area impacted by a
16 terrorist attack.

17 (2) The availability of personal protective equip-
18 ment for first responders.

19 (3) The availability of home Medkits for first
20 responders and their families for biological incident
21 response.

22 (4) Other related factors.

23 (b) CONTEXT.—In preparing the report required
24 under subsection (a), the Comptroller General of the
25 United States may, as appropriate, provide information—

1 (1) in a format that delineates high risk urban
2 areas from rural communities; and

3 (2) on the degree to which the selected State
4 and local programs and policies included in such re-
5 port were developed or are being executed with fund-
6 ing from the Department of Homeland Security, in-
7 cluding grant funding from the State Homeland Se-
8 curity Grant Program or the Urban Area Security
9 Initiative under sections 2002 and 2003, respec-
10 tively, of the Homeland Security Act of 2002 (6
11 U.S.C. 603 and 604).

12 (c) **HOMELAND SECURITY CONSIDERATION.**—After
13 issuance of the report required under subsection (a), the
14 Secretary of Homeland Security shall consider such re-
15 port’s findings and assess its applicability for Federal first
16 responders.
