3 **SECTION 1. REPLACEMENT OF JOHN H. CHAFEE COASTAL**
4 **BARRIER RESOURCES SYSTEM MAP.**

5 (a) *IN GENERAL.*—*The map subtitled “Sachuest Point*
6 *Unit RI–04P, Easton Beach Unit RI–05P, Almy Pond*
7 *Unit RI–06, Hazards Beach Unit RI–07”, included in the*
8 *set of maps entitled “John H. Chafee Coastal Barrier Re-*
9 *sources System” referred to in section 4(a) of the Coastal*
10 *Barrier Resources Act (16 U.S.C. 3503(a)) and relating to*
11 *certain John H. Chafee Coastal Barrier Resources System*
12 *units in Rhode Island, is hereby replaced by another map*
13 *relating to the units entitled “John H. Chafee Coastal Bar-*
14 *rier Resources System Sachuest Point Unit RI–04P, Easton*
15 *Beach Unit RI–05P, Almy Pond Unit RI–06, and Hazards*
16 *Beach Unit RI–07” and dated September 16, 2013.*

17 (b) *AVAILABILITY.*—*The Secretary of the Interior shall*
18 *keep the replacement map referred to in subsection (a) on*
19 *file and available for inspection in accordance with the pro-*
20 *visions of section 4(b) of the Coastal Barrier Resources Act*
