3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Lower Rogue Wild and
- 5 Scenic River Expansion Act".

6 SEC. 2. ROGUE RIVER ADDITIONS.

7 (a) AMENDMENTS.—Section 3(a)(5) of the Wild and

9	Centennial Gulch Creek from its head-
10	waters to the confluence with the Rogue
11	River as a recreational river.
12	"(xxxii) COPSEY CREEK.—The ap-
13	proximately 1.5 miles of Copsey Creek
14	from its headwaters to the confluence with
15	the Rogue River as a wild river.
16	"(xxxiii) Corral creek.—The ap-
17	proximately 0.5 miles of Corral Creek from
18	its headwaters to the confluence with the
19	Rogue River as a wild river.
20	"(xxxiv) Cowley creek.—The ap-
21	proximately 0.9 miles of Cowley Creek
22	from its headwaters to the confluence with
23	the Rogue River as a wild river.
24	"(xxxv) Ditch creek.—

1	((I) The approximately 0.5-mile
2	section of Ditch Creek from its head-
3	waters to 0.1 miles downstream from
4	road 33–5–9.2 as a scenic river.
5	"(II) The approximately 1.9-mile
6	section of Ditch Creek from 0.1 miles
7	downstream from road 33–5–9.2 to
8	its confluence with the Rogue River as
9	a wild river.
10	"(xxxvi) Francis creek.—The ap-
11	proximately 0.9 miles of Francis Creek
12	from its headwaters to the confluence with
13	the Rogue River as a wild river.
14	"(xxxvii) Long gulch.—
15	"(I) The approximately 1.4-mile
16	section of Long Gulch from the head-
17	waters to 0.1 miles downstream from
18	road 34–9–21 as a scenic river.
19	"(II) The approximately 1.1-mile
20	section of Long Gulch from 0.1 miles
21	downstream of road 34–9–21 to the
22	confluence with the Rogue River as a
22 23	confluence with the Rogue River as a wild river.

1	"(I) The approximately 1.0-mile
2	section of Bailey Creek from its head-
3	waters to 0.1 miles downstream from
4	road 34–8–22.2 as a scenic river.
5	"(II) The approximately 2.1-mile
6	section of Bailey Creek from 0.1 miles
7	downstream from road 34–8–22.2 to
8	the confluence of the Rogue River as
9	a wild river.
10	"(xxxix) Shady creek.—The ap-
11	proximately 0.7 miles of Shady Creek from
12	its headwaters to the confluence with the

14	"(xl) SLIDE CREEK.—
15	"(I) The approximately 0.5-mile
16	section of Slide Creek from its head-
17	waters to 0.1 miles downstream from
18	road 33–9–6 as a scenic river.
19	"(II) The approximately 0.7-mile
20	section of Slide Creek from 0.1 miles
21	downstream of road 33–9–6 to the
22	confluence with the Rogue River as a
23	wild river.
24	"(C) IN GENERAL.—River segments re-
25	ferred to in subparagraph (B) shall include an

1 average of 640 acres per mile measured from 2 the ordinary high water mark on both sides of 3 the river. All such wild, scenic, and recreation 4 areas shall be managed as part of the Rogue 5 Wild and Scenic River.". 6 (b) WITHDRAWAL.—Subject to valid rights, the Fed-7 eral land within the boundaries of the river segments designated by subparagraph (B) of section 3(a)(5) of the 8 9 Wild and Scenic Rivers Act (16 U.S.C. 1274(a)(5)), as 10 added by subsection (a) of this section, is withdrawn from 11 all forms of-12 (1) entry, appropriation, or disposal under the public land laws; 13 14 (2) location, entry, and patent under the mining 15 laws; and 16 (3) disposition under all laws pertaining to min-17 eral and geothermal leasing or mineral materials.
