A BILL

To ensure that authorizations issued by the Secretary of Transportation to foreign air carriers do not undermine labor rights or standards, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fair and Open Skies
5 Act”.

6 **SEC. 2. FOREIGN AIR TRANSPORTATION UNDER UNITED**
7 **STATES-EUROPEAN UNION AIR TRANSPORT**
8 **AGREEMENT.**

9 The Secretary of Transportation may not issue a per-
10 mit under section 41302 of title 49, United States Code,
11 or an exemption under section 40109 of such title, author-
12 izing a person to provide foreign air transportation as a
13 foreign air carrier under the United States-European
14 Union Air Transport Agreement of April 2007 (as amend-
15 ed), unless the Secretary—

16 (1) finds that issuing the permit or exemption
17 would be consistent with Article 17 bis of the Agree-
18 ment; and

19 (2) imposes on the permit or exemption such
20 conditions as may be necessary to ensure that the
21 person complies with Article 17 bis.

22 **SEC. 3. PUBLIC INTEREST TEST.**

23 Section 41302(2) of title 49, United States Code, is
24 amended—

1 (1) in subparagraph (A) by striking “under an
2 agreement with the United States Government; or”
3 and inserting “; and”; and

4 (2) in subparagraph (B) by striking “the for-
5 eign air transportation” and inserting “after consid-
6 ering the totality of the circumstances, including the
7 factors set forth in section 40101(a), the foreign air
8 transportation”.

9 **SEC. 4. PUBLIC INTEREST REQUIREMENTS.**

10 (a) **POLICY.**—Section 40101(a) of title 49, United
11 States Code, is amended by adding at the end the fol-
12 lowing:

13 “(17) preventing entry into United States mar-
14 kets by flag of convenience carriers.

15 “(18) preventing the undermining of labor
16 standards.”.

17 (b) **INTERNATIONAL AIR TRANSPORTATION.**—Sec-
18 tion 40101(e)(9) of title 49, United States Code, is
19 amended—

20 (1) in subparagraph (D) by striking “and” at
21 the end;

22 (2) in subparagraph (E) by striking the period
23 at the end and inserting “; and”; and

24 (3) by adding at the end the following:

25 “(F) undermining labor standards.”.

1 (c) FLAG OF CONVENIENCE CARRIER DEFINED.—
2 Section 40102(a) of title 49, United States Code, is
3 amended—

4 (1) by redesignating paragraphs (21) through
5 (47) as paragraphs (22) through (48), respectively;
6 and

7 (2) by inserting after paragraph (20) the fol-
8 lowing:

9 “(21) ‘flag of convenience carrier’ means a for-
10 eign air carrier that is established in a country other
11 than the home country of its majority owner or own-
12 ers in order to avoid regulations of the home coun-
13 try.”.
