A BILL

To amend title 49, United States Code, to codify requirements for changes in airport sponsorship or operations with respect to airport operating certificates, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Airport Transfer of
- 5 License Act".

1	SEC. 2. CHANGES IN AIRPORT SPONSORSHIP OR OPER-
2	ATIONS.
3	Section 44706 of title 49, United States Code, is
4	amended—
5	(1) by redesignating subsection (f) as sub-
6	section (h); and
7	(2) by inserting after subsection (e) the fol-
8	lowing:
9	"(f) Change of Airport Sponsorship or Oper-
10	ATIONS.—
11	"(1) Undisputed change of airport spon-
12	SORSHIP OR OPERATIONS.—Except as provided for
13	in paragraph (2), for a proposed transfer of the
14	sponsorship or operations of an airport to a new
15	sponsor or operator, the Administrator shall issue an
16	airport operating certificate to a new sponsor or op-
17	erator if—
18	"(A) the holder of the airport operating
19	certificate for such airport consents to the
20	transfer of sponsorship or operations; and
21	"(B) the new sponsor or operator satisfies
22	all requirements for obtaining a certificate
23	under this section.
24	"(2) Disputed Change of Airport sponsor-
25	SHIP OR OPERATIONS.—For a proposed transfer of
26	the sponsorship or operations of an airport to a new

1	sponsor or operator for which the holder of the air-
2	port operating certificate disputes such transfer, the
3	Administrator shall issue an airport operating cer-
4	tificate to the new sponsor if the new sponsor or op-
5	erator satisfies all requirements for obtaining a cer-
6	tificate under this section and the dispute is resolved
7	by—
8	"(A) the issuance of a final, non-appeal-
9	able judicial decision requiring a change of
10	sponsorship or operations;
11	"(B) the issuance of a consent letter be-
12	tween the holder of an airport operating certifi-
13	cate and a new sponsor or operator; or
14	"(C) any other legally definitive means of
15	requiring a change of sponsorship or operations
16	that the Administrator determines appropriate.
17	"(g) Reimbursement of Airport Investment.—
18	After a change in sponsorship or operations under sub-
19	section (f), the new airport sponsor or operator shall reim-
20	burse the previous holder of an airport operating certifi-
21	cate for investments made by such holder that have not
22	been fully recouped as of the change in airport sponsorship
23	or operations and such reimburgement shall be consistent

- 1 with all policies and procedures of the Federal Aviation
- 2 Administration.".
