Mr. ISSA introduced the following bill; which was referred to the Committee on Oversight and Government Reform

A BILL

To amend title 5, United States Code, to deny Federal retirement benefits to individuals convicted of certain offenses, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DENIAL OF FEDERAL RETIREMENT BENEFITS.**

4 (a) CONVICTION OF CERTAIN OFFENSES.—

5 (1) IN GENERAL.—Section 8312(a) of title 5,
6 United States Code, is amended—

7 (A) by striking “or” at the end of para-
8 graph (1);

9 (B) by striking the period at the end of
10 paragraph (2) and inserting “; or”; and

1 (C) by adding after paragraph (2) the fol-
2 lowing:

3 “(3) was convicted, after the date of the enact-
4 ment of this paragraph, of an offense named by sub-
5 section (e), to the extent provided by that sub-
6 section.”.

7 (2) APPLICABILITY.—The last sentence of sec-
8 tion 8312(a) of such title 5 is amended—

9 (A) by striking “and” at the end of sub-
10 paragraph (A);

11 (B) by striking the period at the end of
12 subparagraph (B) and inserting “; and”; and

13 (C) by adding after subparagraph (B) the
14 following:

15 “(C) with respect to the offenses named by sub-
16 section (e), to the period after the date of convic-
17 tion.”.

18 (3) OFFENSES SPECIFIED.—Section 8312 of
19 such title 5 is amended by adding at the end the fol-
20 lowing:

21 “(e) The following are offenses to which subsection
22 (a) applies:

23 “(1) An offense within the purview of section
24 641 of title 18, committed after the date of the en-
25 actment of this subsection.

1 “(2) Perjury committed under the statutes of
2 the United States or the District of Columbia in
3 falsely denying the commission of an act which con-
4 stitutes an offense within the purview of paragraph
5 (1).

6 “(3) Subornation of perjury committed in con-
7 nection with the false denial of another individual as
8 specified by paragraph (3).”.

9 (b) ABSENCE FROM UNITED STATES TO AVOID
10 PROSECUTION.—Section 8313(a)(1) of title 5, United
11 States Code, is amended—

12 (1) by striking “or” at the end of subparagraph
13 (A);

14 (2) by striking “; and” at the end of subpara-
15 graph (B) and inserting “; or”; and

16 (3) by adding after subparagraph (B) the fol-
17 lowing:

18 “(C) after the date of the enactment of
19 subsection (e) of section 8312, for an offense
20 named by such subsection; and”.

21 (c) REFUND OF CONTRIBUTIONS AND DEPOSITS.—
22 Section 8316(b) of title 5, United States Code, is amend-
23 ed—

24 (1) by striking “or” at the end of paragraph
25 (1);

1 (2) by striking the period at the end of para-
2 graph (2) and inserting “; or”; and

3 (3) by adding after paragraph (2) the following:

4 “(3) if the individual was convicted of an of-
5 fense named by subsection (e) of section 8312, for
6 the period after the conviction.”.
