A BILL

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Protecting Access To*
5 *Information for Effective & Necessary Treatment and Serv-*
6 *ices Act” or the “PATIENTS Act”.*

7 **SEC. 2. EXTENDING APPROPRIATIONS AND TRANSFERS TO**
8 **THE PATIENT-CENTERED OUTCOMES RE-**
9 **SEARCH TRUST FUND; EXTENSION OF CER-**
10 **TAIN HEALTH INSURANCE FEES.**

11 *(a) IN GENERAL.—*

12 *(1) INTERNAL REVENUE CODE.—Section 9511 of*
13 *the Internal Revenue Code of 1986 is amended—*

14 *(A) in subsection (b)(1)(E), by striking*
15 *“2014” and all that follows through “2019” and*
16 *inserting “2014 through 2026”;*

17 *(B) in subsection (d)(2)(A), by striking*
18 *“2019” and inserting “2026”; and*

19 *(C) in subsection (f), by striking “2019”*
20 *and inserting “2026”.*

21 *(2) TITLE XI OF THE SOCIAL SECURITY ACT.—*

22 *Section 1183(a)(2) of the Social Security Act (42*
23 *U.S.C. 1320e-2(a)(2)) is amended by striking “2014”*
24 *and all that follows through “2019” and inserting*
25 *“2014 through 2026”.*

1 **(b) EXTENSION OF CERTAIN HEALTH INSURANCE**
2 *FEES.*—

3 **(1) HEALTH INSURANCE POLICIES.**—Section
4 *4375(e) of the Internal Revenue Code of 1986 is*
5 *amended by striking “2019” and inserting “2026”.*

6 **(2) SELF-INSURED HEALTH PLANS.**—Section
7 *4376(e) of the Internal Revenue Code of 1986 is*
8 *amended by striking “2019” and inserting “2026”.*

9 **(c) PCORI RESEARCH PRIORITIES.**—Section
10 *1181(d)(1)(A) of the Social Security Act (42 U.S.C.*
11 *1320e(d)(1)(A)) is amended by adding at the end the fol-*
12 *lowing new sentence: “Such national priorities shall in-*
13 *clude research with respect to substance use (including*
14 *opioid use disorders), mental health, and maternal mor-*
15 *bidity and mortality.”.*
