A BILL

To authorize the Fallen Journalists Memorial Foundation to establish a commemorative work in the District of Columbia and its environs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Fallen Journalists Me-*
5 *morial Act”.*

6 **SEC. 2. AUTHORIZATION TO ESTABLISH COMMEMORATIVE**
7 **WORK.**

8 *(a) IN GENERAL.—The Fallen Journalists Memorial*
9 *Foundation may establish a commemorative work on Fed-*
10 *eral land in the District of Columbia and its environs to*
11 *commemorate America’s commitment to a free press as rep-*
12 *resented by journalists who sacrificed their lives in their*
13 *line of work.*

14 *(b) COMPLIANCE WITH STANDARDS FOR COMMEMORA-*
15 *TIVE WORKS.—The establishment of the commemorative*
16 *work under this section shall be in accordance with chapter*
17 *89 of title 40, United States Code (commonly known as the*
18 *“Commemorative Works Act”).*

19 *(c) PROHIBITION ON USE OF FEDERAL FUNDS.—*

20 *(1) IN GENERAL.—Federal funds may not be*
21 *used to pay any expense of the establishment of the*
22 *commemorative work under this section.*

23 *(2) RESPONSIBILITY OF THE FALLEN JOURNAL-*
24 *ISTS MEMORIAL FOUNDATION.—The Fallen Journal-*
25 *ists Memorial Foundation shall be solely responsible*

1 *for acceptance of contributions for, and payment of*
2 *the expenses of, the establishment of the commemora-*
3 *tive work under this section.*

4 *(d) DEPOSIT OF EXCESS FUNDS.—*

5 *(1) IN GENERAL.—If upon payment of all ex-*
6 *penses for the establishment of the commemorative*
7 *work (including the maintenance and preservation*
8 *amount required by section 8906(b)(1) of title 40,*
9 *United States Code), there remains a balance of funds*
10 *received for the establishment of the commemorative*
11 *work, the Fallen Journalists Memorial Foundation*
12 *shall transmit the amount of the balance to the Sec-*
13 *retary of the Interior for deposit in the account pro-*
14 *vided for in section 8906(b)(3) of title 40, United*
15 *States Code.*

16 *(2) ON EXPIRATION OF AUTHORITY.—If upon ex-*
17 *piration of the authority for the commemorative work*
18 *under section 8903(e) of title 40, United States Code,*
19 *there remains a balance of funds received for the es-*
20 *tablishment of the commemorative work, the Fallen*
21 *Journalists Memorial Foundation shall transmit the*
22 *amount of the balance to a separate account with the*
23 *National Park Foundation for memorials, to be avail-*
24 *able to the Secretary of the Interior or Administrator*
25 *(as appropriate) following the process provided in sec-*

1 *tion 8906(b)(4) of title 40, United States Code, for ac-*
2 *counts established under section 8906(b)(2) or (3) of*
3 *title 40, United States Code.*
