## A BILL

To amend the Higher Education Act of 1965 to require that certain information with respect to nutrition assistance programs be annually disclosed, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Supporting Trans-  
5 parency to Overcome Poverty and Campus Hunger Act”  
6 or the “STOP Campus Hunger Act”.

1 **SEC. 2. STUDENT ELIGIBILITY INFORMATION FOR NUTRI-**  
2 **TION ASSISTANCE PROGRAMS.**

3 (a) INFORMATION DISSEMINATION ACTIVITIES.—  
4 Section 485(a)(1) of the Higher Education Act of 1965  
5 (20 U.S.C. 1092(a)(1)) is amended—

6 (1) in subparagraph (U), by striking the “and”  
7 at the end;

8 (2) in subparagraph (V), by striking the period  
9 at the end and inserting a semicolon; and

10 (3) by adding at the end the following:

11 “(W) the most recent relevant student eli-  
12 gibility guidance with respect to the nutrition  
13 assistance programs established under—

14 “(i) section 4 of the Food and Nutri-  
15 tion Act of 2008 (7 U.S.C. 2014); and

16 “(ii) section 17 of the Child Nutrition  
17 Act of 1966 (42 U.S.C. 1786);

18 “(X) the contact information for the State  
19 agencies responsible for administration of the  
20 programs specified in clauses (i) and (ii) of sub-  
21 paragraph (W); and

22 “(Y) the food pantries and other food as-  
23 sistance facilities and services available to stu-  
24 dents enrolled in such institution.”.

25 (b) COLLEGE NAVIGATOR WEBSITE.—Not later than  
26 30 days after the date of the enactment of this Act, the

1 Secretary of Education shall make available and annually  
2 update on the College Navigator Website the most recent  
3 relevant student eligibility guidance with respect to the nu-  
4 trition assistance programs established under—

5           (1) section 4 of the Food and Nutrition Act of  
6           2008 (7 U.S.C. 2014); and

7           (2) section 17 of the Child Nutrition Act of  
8           1966 (42 U.S.C. 1786).
