SHORT TITLE.** 4 This Act may be cited as the "No Human Trafficking" 5 on Our Roads Act". 6 SEC. 2. LIFETIME DISQUALIFICATION WITHOUT REIN-7 STATEMENT. 8 Section 31310(d) of title 49, United States Code, is 9 amended-10 (1) in the heading, by striking "CONTROLLED 11 SUBSTANCE VIOLATIONS" and inserting "LIFETIME 12 **DISQUALIFICATION WITHOUT REINSTATEMENT'';** (2) by striking "The Secretary" and inserting 13 14 "(1) CONTROLLED SUBSTANCE VIOLATIONS.—The 15 Secretary"; and (3) by adding at the end the following: 16 17 "(2) HUMAN TRAFFICKING VIOLATIONS.—The 18 Secretary shall disqualify from operating a commer-19 cial motor vehicle for life an individual who uses a 20 commercial motor vehicle in committing a felony in-21 volving an act or practice described in paragraph (9) 22 of section 103 of the Trafficking Victims Protection 23 Act of 2000 (22 U.S.C. 7102(9)).".
