A BILL

To amend title 28, United States Code, to protect the right of a claimant in a civil action before a Federal court to retain a structured settlement broker to negotiate the terms of payment of an award, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Structured Settlement
- 5 Claimants Rights Act of 2012".

SEC. 2. IN GENERAL.

- 2 (a) Federal Court Proceedings.—Chapter 111
- 3 of title 28, United States Code, is amended by adding at
- 4 the end the following:

5 "§ 1660. Right to retain structured settlement broker

- 6 "A claimant in any civil action before a Federal court
- 7 shall have the right to retain a structured settlement
- 8 broker to act on behalf of that claimant for purposes of
- 9 negotiating a schedule of payments or other terms of pay-
- 10 ment of a sum certain previously agreed to paid by or on
- 11 behalf of the defendant in satisfaction of a judgment
- 12 against that defendant or in accordance with the terms
- 13 of a settlement. The court shall inform the claimant of
- 14 this right at the appropriate time. The defendant shall
- 15 provide timely notice of any professional relationship be-
- 16 tween the defendant and the broker if any such relation-
- 17 ship exists or has existed.".
- 18 (b) Administrative Proceedings.—Section 554 of
- 19 title 5, United States Code, is amended by adding at the
- 20 end the following:
- 21 "(f) In the case of any proceeding under this section,
- 22 a party to that proceeding shall have the right to retain
- 23 a structured settlement broker to act on behalf of that
- 24 party for purposes of negotiating a schedule of payments
- 25 or other terms of payment of a sum certain previously
- 26 agreed to paid by or on behalf of another party in satisfac-

- 1 tion of a decision against that party or in accordance with
- 2 the terms of a settlement between the parties. The agency
- 3 shall inform the claimant of this right at the appropriate
- 4 time. The defendant shall provide timely notice of any pro-
- 5 fessional relationship between the defendant and the
- 6 broker if any such relationship exists or has existed.".
