A BILL

To amend the Wild and Scenic Rivers Act to designate segments of the Kissimmee River in the State of Florida as a component of the Wild and Scenic Rivers System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Kissimmee River Wild*
5 *and Scenic River Act”.*

6 **SEC. 2. DESIGNATION FOR STUDY OF WILD AND SCENIC**
7 **RIVER SEGMENTS, KISSIMMEE RIVER, FLOR-**
8 **IDA.**

9 *Section 5(a) of the Wild and Scenic Rivers Act (16*
10 *U.S.C. 1276(a)) is amended by adding at the end the fol-*
11 *lowing:*

12 “(____) KISSIMMEE RIVER, FLORIDA.—The re-
13 *stored segment of the Kissimmee River, beginning ap-*
14 *proximately 16 miles downstream of Lake Kissimmee*
15 *and ending approximately 15 miles upstream of Lake*
16 *Okeechobee.”.*

17 **SEC. 3. STUDIES AND REPORTS.**

18 *Section 5(b) of the Wild and Scenic Rivers Act (16*
19 *U.S.C. 1276(b)) is amended by adding at the end the fol-*
20 *lowing:*

21 “(____) KISSIMMEE RIVER, FLORIDA.—Not later
22 *than 3 years after the date on which funds are made*
23 *available to carry out this paragraph, the Secretary*
24 *of the Interior shall—*

1 “(A) complete the study of the Kissimmee
2 River, Florida named in paragraph (_____) of sub-
3 section (a); and

4 “(B) submit to the Committee on Natural
5 Resources of the House of Representatives and
6 the Committee on Energy and Natural Resources
7 of the Senate a report that describes the results
8 of the study.”.

9 **SEC. 4. EFFECT ON MANAGEMENT.**

10 This Act and the amendments made by this Act shall
11 not interfere with the current management of the area of
12 the Kissimmee River described in section 5(a)(_____) of the
13 Wild and Scenic Rivers Act, nor shall the fact that such
14 area is listed for study under the Wild and Scenic Rivers
15 Act (16 U.S.C. 1271 et seq.) be used as justification for more
16 restrictive management until Congress acts on the study
17 recommendations.
