## A BILL

To establish a block grant program to enable southwest border States to construct barriers along their borders with Mexico, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Securing Our Border  
5 States Act”.

1 **SEC. 2. ESTABLISHMENT OF BLOCK GRANT PROGRAM TO**  
2 **ENABLE SOUTHWEST BORDER STATES TO**  
3 **CONSTRUCT BARRIERS ALONG THEIR BOR-**  
4 **DERS WITH MEXICO.**

5 (a) IN GENERAL.—Notwithstanding any other provi-  
6 sion of law, not later than 30 days after the President  
7 receives from the Governor of a southwest border State  
8 a certification that the Governor intends to use covered  
9 block grant funding for the construction of a southwest  
10 border barrier, including continuing the construction of  
11 portions of existing border barrier, and associated infra-  
12 structure, including physical barriers and associated detec-  
13 tion technology, roads, and lighting, the President shall—

14 (1) acting through the Secretary of the Treas-  
15 ury, disburse an appropriate prorated amount of  
16 such block grant funding, as determined under sub-  
17 section (b); and

18 (2) ensure that all relevant Federal entities  
19 take such actions as may be necessary to allow for  
20 such construction.

21 (b) DETERMINATION OF GRANT AMOUNT.—Not later  
22 than 30 days after the date of the enactment of this Act,  
23 the Secretary of Homeland Security shall—

24 (1) determine the number of miles along the  
25 border between each southwest border State and  
26 Mexico where there is no border barrier; and

1           (2) determine the pro-rated amount each south-  
2 west border State may receive under this section on  
3 the basis of the determination with respect to such  
4 State under paragraph (1).

5           (c) EMPOWERING STATES TO BUILD THE WALL  
6 FUND.—

7           (1) ESTABLISHMENT.—There is hereby estab-  
8 lished in the General Fund of the Treasury a fund  
9 to be known as the “Empowering States To Build  
10 the Wall Fund”. Amounts deposited in the Fund  
11 shall be available without fiscal year limitation dur-  
12 ing the five-year period beginning on the date of the  
13 first disbursement from the Fund for the purpose of  
14 making grants to southwest border States under this  
15 section.

16           (2) APPROPRIATIONS.—There is hereby appro-  
17 priated to the Empowering States To Build the Wall  
18 Fund \$22,000,000,000.

19           (3) RESCISSION OF CERTAIN FEDERAL FUNDS  
20 APPROPRIATED FOR STATE, LOCAL, AND TRIBAL  
21 GOVERNMENTS.—Notwithstanding any other provi-  
22 sion of law, there are hereby permanently rescinded  
23 \$22,000,000,000 of the total amount of unobligated  
24 funds available under any of sections 601 through  
25 603 of title VI of the Social Security Act.

1           (d) SOUTHWEST BORDER STATE DEFINED.—In this  
2 section, the term “southwest border State” means Texas,  
3 New Mexico, Arizona, or California.
