# **A BILL**

To authorize the Every Word We Utter Monument to establish a commemorative work in the District of Columbia and its environs, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SEC. 1. AUTHORIZATION TO ESTABLISH COMMEMORATIVE**  
4 **WORK.**

5        (a) *IN GENERAL.—The Every Word We Utter Monu-*  
6 *ment may establish a commemorative work on Federal land*  
7 *in the District of Columbia and its environs to commemo-*  
8 *rate the passage of the 19th Amendment to the Constitution,*  
9 *which gave women the right to vote.*

10        (b) *COMPLIANCE WITH STANDARDS FOR COMMEMORA-*  
11 *TIVE WORKS.—The establishment of the commemorative*  
12 *work under this section shall be in accordance with chapter*  
13 *89 of title 40, United States Code (commonly known as the*  
14 *“Commemorative Works Act”).*

15        (c) *PROHIBITION ON THE USE OF FEDERAL FUNDS.—*

16            (1) *IN GENERAL.—Federal funds may not be*  
17 *used to pay any expense of the establishment of the*  
18 *commemorative work under this section.*

19            (2) *RESPONSIBILITY OF THE EVERY WORD WE*  
20 *UTTER MONUMENT.—The Every Word We Utter*  
21 *Monument shall be solely responsible for acceptance of*  
22 *contributions for, and payment of the expenses of, the*  
23 *establishment of the commemorative work under this*  
24 *section.*

25        (d) *DEPOSIT OF EXCESS FUNDS.—*

1           (1) *IN GENERAL.*—If upon payment of all ex-  
2           penses for the establishment of the memorial (includ-  
3           ing the maintenance and preservation amount re-  
4           quired by section 8906(b)(1) of title 40, United States  
5           Code), there remains a balance of funds received for  
6           the establishment of the commemorative work, the  
7           *Every Word We Utter Monument* shall transmit the  
8           amount of the balance to the Secretary of the Interior  
9           for deposit in the account provided for in section  
10          8906(b)(3) of title 40, United States Code.

11          (2) *ON EXPIRATION OF AUTHORITY.*—If upon ex-  
12          piration of the authority for the commemorative work  
13          under section 8903(e) of title 40, United States Code,  
14          there remains a balance of funds received for the es-  
15          tablishment of the commemorative work, the *Every*  
16          *Word We Utter Monument* shall transmit the amount  
17          of the balance to a separate account with the National  
18          Park Foundation for memorials, to be available to the  
19          Secretary of the Interior or Administrator (as appro-  
20          priate) following the process provided in section  
21          8906(b)(4) of title 40, United States Code, for ac-  
22          counts established under 8906(b)(2) or (3) of title 40,  
23          United States Code.
