7	(a) In General.—Subsection (c) of section 45D of
8	the Internal Revenue Code of 1986 (defining qualified
9	community development entity) is amended by adding at
10	the end the following new paragraph:

12	RISDICTIONS.—A corporation or partnership created
13	or organized in, or under the laws of, American
14	Samoa, the Commonwealth of the Northern Mariana
15	Islands, Guam, Puerto Rico, or the Virgin Islands
16	shall be treated as a domestic corporation or part-
17	nership for purposes of paragraph (1).".
18	(b) Effective Date.—The amendment made by
19	subsection (a) shall apply to investments made after the
20	date of the enactment of this Act.
