To oppose violations of religious freedom in Ukraine by Russia and armed groups commanded or otherwise supported by or acting on behalf of Russia.

- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Ukraine Religious
- 3 Freedom Support Act".

4 SEC. 2. STATEMENT OF POLICY.

- 5 It is the policy of the United States—
- 6 (1) to never recognize the illegal, attempted an-7 nexation of Crimea by the Government of the Russia 8 or the separation through the use of military force 9 or recognition of independence of any portion of 10 Ukrainian territory; and
- 11 (2) to consider any alien who, while serving as 12 an official of the Government of Russia, was respon-13 sible for or directly carried out particularly severe 14 violations of religious freedom in the sovereign terri-15 tory of Ukraine that Russia illegally occupies, con-16 recognizes as independent, including 17 through non-state armed groups and illegal entities 18 it commands or otherwise supports or which act on 19 Russia's behalf, to have committed particularly se-20 vere violations of religious freedom for purposes of 21 applying section 212(a)(2)(G) of the Immigration and Nationality Act (8 U.S.C. 1182(a)(2)(G)) with 22 23 respect to any such alien.

4	For purposes of making a determination of whether				
5	to designate Russia as a country of particular concern for				
6	religious freedom under section 402 of the International				
7	Religious Freedom Act of 1998 (22 U.S.C. 6442), the				
8	President shall consider any particularly severe violation				
9	of religious freedom in the territory of Ukraine that Rus-				
10	sia illegally occupies, controls, or recognizes as inde-				
11	pendent, including through non-state armed groups and				
12	illegal entities it commands or otherwise supports or which				
13	act on Russia's behalf, during the period of time that is				
14	the basis for the determination and designation, to be a				
15	particularly severe violation of religious freedom that the				
16	Government of Russia has engaged in or tolerated.				
17	SEC. 4. DETERMINATION OF BUDGETARY EFFECTS.				
18	The budgetary effects of this Act, for the purpose of				
19	complying with the Statutory Pay-As-You-Go Act of 2010,				
20	shall be determined by reference to the latest statement				
21	titled "Budgetary Effects of PAYGO Legislation" for this				
22	Act, submitted for printing in the Congressional Record				

23 by the Chairman of the House Budget Committee, pro-
