# **A BILL**

To amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to provide or assist in providing a vehicle adapted for operation by disabled individuals to certain eligible persons, to pay expenses associated with the delivery of such vehicle, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Deliver for Veterans*  
5 *Act”.*

6 **SEC. 2. ELIGIBILITY FOR DEPARTMENT OF VETERANS AF-**  
7 **FAIRS COVERAGE OF COSTS ASSOCIATED**  
8 **WITH DELIVERY OF AN ADAPTIVE VEHICLE.**

9        *Section 3902(a) of title 38, United States Code, is*  
10 *amended by striking “by paying the total purchase price*  
11 *of the automobile or other conveyance” and inserting “by*  
12 *paying the total purchase price of the automobile or other*  
13 *conveyance, and the total shipping price to deliver the auto-*  
14 *mobile or other conveyance to the veteran”.*

15 **SEC. 3. MODIFICATION OF CERTAIN HOUSING LOAN FEES.**

16        *The loan fee table in section 3729(b)(2) of title 38,*  
17 *United States Code, is amended by striking “November 15,*  
18 *2031” each place it appears and inserting “November 20,*  
19 *2031”.*
