Mr. FRY (for himself, Mr. GALLEG0, Mr. LAMBORN, and Mr. SANTOS) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To require the Comptroller General of the United States to submit a report on the effects of the fentanyl crisis, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fentanyl Crisis Re-
5 search and Evaluation Act”.

6 **SEC. 2. REPORT ON THE FENTANYL CRISIS.**

7 (a) IN GENERAL.—Not later than one year after the
8 date of the enactment of this Act, the Comptroller General

1 of the United States shall submit to Congress a report
2 on the fentanyl crisis.

3 (b) REPORT.—The report shall include information
4 related to the fentanyl crisis, including the following:

5 (1) The effects, and implications of such ef-
6 fects, on—

7 (A) the general labor market,
8 disaggregated by race and gender, including—

9 (i) the unemployment rate;

10 (ii) the employment to total popu-
11 lation ratio;

12 (iii) the population that is age 16 or
13 older; and

14 (iv) the population that is not younger
15 than age 25 or older than age 54;

16 (B) industry sectors, such as construction
17 and finance;

18 (C) Federal tax revenue;

19 (D) means-tested Federal benefits pro-
20 grams, including Medicaid;

21 (E) Federal health programs, including
22 Medicare;

23 (F) housing instability, including evictions,
24 foreclosures, and homelessness, and the eco-

1 nomic effect on individuals experiencing such
2 instability; and

3 (G) State finances, including the resulting
4 effect on the Federal Government.

5 (2) Information on—

6 (A) the availability of each Federally as-
7 sisted rental housing program to individuals
8 with a known drug conviction;

9 (B) the number of individuals age 18 or
10 younger who have died from a fentanyl over-
11 dose; and

12 (C) actions the Federal Government can
13 take to—

14 (i) mitigate the burden of the fentanyl
15 crisis on States; and

16 (ii) efficiently address such crisis.

17 (c) DEFINITIONS.—In this Act:

18 (1) FEDERALLY ASSISTED RENTAL HOUSING.—

19 The term “Federally assisted rental housing” means
20 a residential dwelling unit that is made available for
21 rent and for which assistance is provided, or that is
22 part of a housing project for which assistance is pro-
23 vided, under any program administered by the Sec-
24 retary of Housing and Urban Development or the
25 Secretary of Agriculture.

1 (2) STATE.—The term “State” means each of
2 the 50 States.
