# **A BILL**

To amend Public Law 93–435 with respect to the Northern Mariana Islands, providing parity with Guam, the Virgin Islands, and American Samoa.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AMENDMENT.**

4        (a) IN GENERAL.—The first section and section 2 of  
5 Public Law 93–435 (48 U.S.C. 1705, 1706) are amended  
6 by inserting “the Commonwealth of the Northern Mariana  
7 Islands,” after “Guam,” each place it appears.

8        (b) REFERENCES TO DATE OF ENACTMENT.—For  
9 the purposes of the amendment made by subsection (a),  
10 each reference in Public Law 93–435 to the “date of en-  
11 actment” shall be considered to be a reference to the date  
12 of the enactment of this section.
