A BILL

To amend the Bipartisan Budget Act of 2018 to extend the provision of assistance for critical services with respect to certain disasters, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Resiliency Enhance-
5 ment Act of 2020”.

6 **SEC. 2. REPAIR, RESTORATION, AND REPLACEMENT OF**
7 **DAMAGED FACILITIES.**

8 (a) IN GENERAL.—Section 20601 of the Bipartisan
9 Budget Act of 2018 (Public Law 115–123) is amended—

10 (1) by striking “, and” and inserting a comma;

11 (2) by inserting “, and including, for purposes
12 of this section, solid waste management, stormwater
13 management, public housing, transportation infra-
14 structure, and medical care,” before “for the dura-
15 tion”; and

16 (3) by inserting “, and any subsequent major
17 disaster (as such term is defined in section 102 of
18 the Robert T. Stafford Disaster Relief and Emer-
19 gency Assistance Act) declared under section 401 of
20 the Robert T. Stafford Disaster Relief and Emer-
21 gency Assistance Act in Puerto Rico or the Virgin
22 Islands on or before September 30, 2022” before
23 “to—”.

1 (b) EFFECTIVE DATE.—The amendments made by
2 subsection (a) shall take effect as if included in section
3 20601 of Public Law 115–123.
