Mr. BARR (for himself and Ms. GABBARD) introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To amend title 38, United States Code, to improve the care furnished to veterans with military sexual trauma.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Military Sexual Assault
5 Victims Empowerment Act” or the “Military SAVE Act”.

6 **SEC. 2. IMPROVEMENTS TO CARE FOR VETERANS WITH**
7 **MILITARY SEXUAL TRAUMA.**

8 (a) **COMMUNITY CARE.**—Section 1703(d) of title 38,
9 United States Code, is amended—

10 (1) in paragraph (1)—

1 (A) in subparagraph (D), by striking “;
2 or” and inserting a semicolon;

3 (B) in subparagraph (E), by striking the
4 period at the end and inserting “; or”; and

5 (C) by adding at the end the following new
6 subparagraph:

7 “(F) a covered veteran is seeking coun-
8 seling, care, or services for which the person is
9 eligible under section 1720D of this title.”;

10 (2) in paragraph (3)—

11 (A) by striking “subparagraph (C) of such
12 paragraph, or that” and inserting “subpara-
13 graph (C) of such paragraph, that”; and

14 (B) by inserting “or that the covered vet-
15 eran is seeking counseling or care or services
16 for which the person is eligible under section
17 1720D of this title,” after “subparagraph (D)
18 of such paragraph,”; and

19 (3) by adding at the end the following new
20 paragraph:

21 “(4) The Secretary shall provide to covered veterans
22 described in paragraph (1)(F) information regarding the
23 counseling, care, and services available to the covered vet-
24 eran through the Department with respect to the coun-
25 seling, care, and services described in such paragraph.”.

1 (b) IMPROVEMENTS TO MILITARY SEXUAL TRAUMA
2 TREATMENT AUTHORITY.—Section 1720D of such title is
3 amended—

4 (1) in subsection (a)—

5 (A) paragraph (1), by striking “overcome
6 psychological trauma, which in the judgment of
7 a mental health professional” and inserting
8 “treat any condition, which in the judgment of
9 a health care professional”;

10 (B) in paragraph (2)(A), by striking “over-
11 come psychological trauma” and inserting
12 “treat conditions”;

13 (C) by amending paragraph (3) to read as
14 follows:

15 “(3) A veteran may receive counseling and care and
16 services under this section through the Veterans Commu-
17 nity Care program in accordance with section 1703(d) of
18 this title.”; and

19 (D) in subsection (b)(2), by striking
20 “counseling” each place it appears and insert-
21 ing “counseling and care and services”.
