A BILL

To support remediation of illicit cross-border tunnels, and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “DHS Illicit Cross-Bor-*
5 *der Tunnel Defense Act”.*

6 **SEC. 2. COUNTER ILLICIT CROSS-BORDER TUNNEL OPER-**
7 **ATIONS.**

8 *(a) REPORT ON OPERATIONS.—*

9 *(1) IN GENERAL.—Not later than one year after*
10 *the date of the enactment of this Act and annually*
11 *thereafter, the Commissioner of U.S. Customs and*
12 *Border Protection shall submit to the Committee on*
13 *Homeland Security of the House of Representatives*
14 *and the Committee on Homeland Security and Gov-*
15 *ernmental Affairs of the Senate a report on oper-*
16 *ations carried out to identify, breach, assess, and re-*
17 *mediate illicit cross-border tunnels, including per-*
18 *formance measures.*

19 *(2) AUTHORIZATION OF APPROPRIATIONS.—*
20 *There is authorized to be appropriated to the Com-*
21 *missioner of U.S. Customs and Border Protection*
22 *\$1,000,000 for each of fiscal years 2021 and 2022 to*
23 *carry out remediation operations of illicit cross-bor-*
24 *der tunnels.*

1 **(b) COUNTER ILLICIT CROSS-BORDER TUNNEL OPER-**
2 **ATIONS STRATEGIC PLAN.—**

3 **(1) IN GENERAL.—***Not later than 180 days after*
4 *the date of the enactment of this Act, the Commis-*
5 *sioner of U.S. Customs and Border Protection shall*
6 *develop a strategic plan to address the following:*

7 **(A)** *Risk-based criteria to be used to*
8 *prioritize the identification, breach, assessment,*
9 *and remediation of illicit cross-border tunnels.*

10 **(B)** *Promote the use of innovative tech-*
11 *nologies to identify, breach, assess, and remediate*
12 *illicit cross-border tunnels in a manner that,*
13 *among other considerations, reduces the impact*
14 *of such activities on surrounding communities.*

15 **(C)** *Processes to share relevant illicit cross-*
16 *border tunnel location, operations, and technical*
17 *information.*

18 **(D)** *Indicators of specific types of illicit*
19 *cross-border tunnels found in each U.S. Border*
20 *Patrol sector identified through operations to be*
21 *periodically disseminated to U.S. Border Patrol*
22 *sector chiefs to educate field personnel.*

23 **(E)** *A counter illicit cross-border tunnel op-*
24 *erations resource needs assessment that includes*
25 *consideration of the following:*

1 (i) *Technology needs.*

2 (ii) *Staffing needs, including the fol-*
3 *lowing:*

4 (I) *A position description for*
5 *counter illicit cross-border tunnel oper-*
6 *ations personnel.*

7 (II) *Any specialized skills re-*
8 *quired of such personnel.*

9 (III) *The number of such full time*
10 *personnel, disaggregated by U.S. Bor-*
11 *der Patrol sector.*

12 (2) *REPORT TO CONGRESS ON STRATEGIC*
13 *PLAN.—Not later than one year after the issuance of*
14 *the strategic plan required under paragraph (1), the*
15 *Commissioner of U.S. Customs and Border Protection*
16 *shall submit to the Committee on Homeland Security*
17 *of the House of Representatives and the Committee on*
18 *Homeland Security and Governmental Affairs of the*
19 *Senate a report on the implementation of paragraph*
20 *(1).*
