A BILL

To amend title XXVII of the Public Health Service Act to provide for coverage of items, services, and immunizations relating to the diagnosis or treatment of COVID-19 under group health plans and health insurance coverage within 15 days of the issuance of a recommendation from the United States Preventive Services Task Force or the Advisory Committee on Immunization Practices.

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Ensuring Affordable
3 COVID-19 Preventive Care Act of 2020”.

4 **SEC. 2. PROVIDING FOR COVERAGE OF ITEMS, SERVICES,
5 AND IMMUNIZATIONS RELATING TO THE DI-
6 AGNOSIS OR TREATMENT OF COVID-19
7 UNDER GROUP HEALTH PLANS AND HEALTH
8 INSURANCE COVERAGE WITHIN 15 DAYS OF
9 THE ISSUANCE OF A RECOMMENDATION
10 FROM THE UNITED STATES PREVENTIVE
11 SERVICES TASK FORCE OR THE ADVISORY
12 COMMITTEE ON IMMUNIZATION PRACTICES.**

13 Section 2713(b) of the Public Health Service Act (42
14 U.S.C. 300gg–13(b)) is amended—

15 (1) in paragraph (1), by striking “The Sec-
16 retary” and inserting “Subject to paragraph (3), the
17 Secretary”; and

18 (2) by adding at the end the following new
19 paragraph:

20 “(3) SPECIAL RULE FOR COVID-19 ITEMS, SERV-
21 ICES, AND IMMUNIZATIONS.—In the case of an item
22 or service that receives a rating described in sub-
23 section (a)(1), or an immunization that receives a
24 recommendation described in subsection (a)(2), that
25 is intended to prevent, diagnose, or treat COVID-19,
26 the requirement described in subsection (a) shall

1 apply to a group health plan and a health insurance
2 issuer offering group or individual health insurance
3 coverage with respect to such item, service, or immu-
4 nization 15 days after the issuance of such rating or
5 recommendation (as applicable).”.
