A BILL

To provide end user exemptions from certain provisions of the Commodity Exchange Act and the Securities Exchange Act of 1934, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Business Risk Mitiga-
5 tion and Price Stabilization Act of 2013”.

6 **SEC. 2. MARGIN REQUIREMENTS.**

7 (a) COMMODITY EXCHANGE ACT AMENDMENT.—
8 Section 4s(e) of the Commodity Exchange Act (7 U.S.C.
9 6s(e)), as added by section 731 of the Dodd-Frank Wall
10 Street Reform and Consumer Protection Act, is amended
11 by adding at the end the following new paragraph:

12 “(4) APPLICABILITY WITH RESPECT TO
13 COUNTERPARTIES.—The requirements of paragraphs
14 (2)(A)(ii) and (2)(B)(ii) shall not apply to a swap in
15 which a counterparty qualifies for an exception
16 under section 2(h)(7)(A) or satisfies the criteria in
17 section 2(h)(7)(D).”.

18 (b) SECURITIES EXCHANGE ACT AMENDMENT.—
19 Section 15F(e) of the Securities Exchange Act of 1934
20 (15 U.S.C. 78o–10(e)), as added by section 764(a) of the
21 Dodd-Frank Wall Street Reform and Consumer Protec-
22 tion Act, is amended by adding at the end the following
23 new paragraph:

24 “(4) APPLICABILITY WITH RESPECT TO
25 COUNTERPARTIES.—The requirements of paragraphs

1 (2)(A)(ii) and (2)(B)(ii) shall not apply to a secu-
2 rity-based swap in which a counterparty qualifies for
3 an exception under section 3C(g)(1) or satisfies the
4 criteria in section 3C(g)(4).”.

5 **SEC. 3. IMPLEMENTATION.**

6 The amendments made by this Act to the Commodity
7 Exchange Act shall be implemented—

8 (1) without regard to—

9 (A) chapter 35 of title 44, United States
10 Code; and

11 (B) the notice and comment provisions of
12 section 553 of title 5, United States Code;

13 (2) through the promulgation of an interim
14 final rule, pursuant to which public comment will be
15 sought before a final rule is issued; and

16 (3) such that paragraph (1) shall apply solely
17 to changes to rules and regulations, or proposed
18 rules and regulations, that are limited to and di-
19 rectly a consequence of such amendments.
