3 **SECTION 1. DEFERRAL OF GAIN INVESTED IN OPPOR-**
4 **TUNITY ZONE PROPERTY EXTENDED TO 2030.**

5 (a) IN GENERAL.—Section 1400Z–2(b)(1)(B) is
6 amended by striking “December 31, 2026” and inserting
7 “December 31, 2030”.

1 (b) **EFFECTIVE DATE.**—The amendments made by
2 this section shall apply to taxable years beginning after
3 the date of enactment of this section.
