Mr. CROW (for himself, Mr. LAMBORN, Mr. HECK, and Mr. YOUNG) introduced the following bill; which was referred to the Committee on Armed Services

A BILL

To amend title 10, United States Code, to codify and rename the Office of Economic Adjustment of the Department of Defense, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the “Defense Community
5 Investment Act”.

6 SEC. 2. FINDINGS.

7 Congress finds the following:

8 (1) The Office of Economic Adjustment,
9 through relationships with defense communities built

1 over the course of years, is uniquely situated and
2 technically staffed to effectively administer the Com-
3 munity Investment Program of the Department of
4 Defense and to help States and communities main-
5 tain strong relationships that address community
6 challenges while simultaneously supporting military
7 readiness.

8 (2) Installation readiness and resiliency does
9 not stop at the fence line, and often requires coordi-
10 nation and planning with other organizations of the
11 Department of Defense, the Armed Forces, other
12 Federal departments and agencies, and communities
13 surrounding military installations.

14 (3) The Community Investment Program en-
15 ables States and communities to organize, evaluate,
16 and plan for appropriate community investments
17 that support the sustainability, readiness, and
18 growth of a military mission at an installation by—

19 (A) addressing impacts that mission
20 growth may have on everything from housing,
21 schools, transportation, utilities, access to med-
22 ical services, and other public services;

23 (B) providing funding to construct, ren-
24 ovate, repair, or expand public schools located

1 on military installations to address capacity and
2 facility condition deficiencies; and

3 (C) improving accessibility and safety of
4 access to medical facilities for wounded war-
5 riors, veterans, staff, and all other eligible bene-
6 ficiaries.

7 (4) The Defense Community Infrastructure
8 Pilot Program authorizes the Secretary of Defense
9 to make grants, conclude cooperative agreements,
10 and provide supplemental funds to address defi-
11 ciencies in community infrastructure supportive of a
12 military installation.

13 (5) The Defense Manufacturing Communities
14 Program authorizes long-term investments by the
15 Secretary of Defense in critical skills, facilities, re-
16 search and development, and small business support
17 by designating and supporting consortiums in order
18 to strengthen national security innovation.

19 (6) The Office of Economic Adjustment con-
20 tinues to help communities affected by base realign-
21 ments and closures to address issues by assisting in
22 land use planning to respond to unanticipated envi-
23 ronmental contamination and the availability of new
24 parcels of land for redevelopment.

16 (C) preserving military readiness, by helping
17 communities, companies, and workers become
18 more agile and responsive to the fluid
19 military needs and requirements.

1 ment and other manmade or natural threats to in-
2 stallation resiliency including—

3 (A) compatible use and joint land use stud-
4 ies;

5 (B) compatible use plans; and

6 (C) military installation resilience reviews.

7 (9) Reductions to the budget of the Office of
8 Economic Adjustment will adversely affect the de-
9 fense community missions the Office supports, harm
10 small businesses, impede efforts to rebuild schools
11 for children of members of the Armed Forces, and
12 compromise readiness and infrastructure resiliency
13 efforts.

14 **SEC. 3. OFFICE OF DEFENSE COMMUNITY COOPERATION
15 AND ECONOMIC ADJUSTMENT.**

16 (a) ESTABLISHMENT.—

17 (1) IN GENERAL.—Chapter 141 of title 10,
18 United States Code, is amended by inserting after
19 section 2391 the following new section:

20 **“§ 2391a. Office of Defense Community Cooperation
21 and Economic Adjustment**

22 “(a) ESTABLISHMENT.—There is in the Office of the
23 Secretary of Defense an Office of Defense Community Co-
24 operation and Economic Adjustment (in this section re-
25 ferred to as the ‘Office’).

1 “(b) HEAD OF OFFICE.—There is a Director of the
2 Office who shall be the head of the Office. The Director
3 shall be appointed by the Secretary of Defense.

4 “(c) DUTIES.—The Office shall—

5 “(1) serve as the office in the Department of
6 Defense with primary responsibility for—

7 “(A) providing assistance to States, coun-
8 ties, municipalities, regions, and other commu-
9 nities to foster cooperation with military instal-
10 lations to enhance the military mission, achieve
11 facility and infrastructure savings and reduced
12 operating costs, address encroachment and
13 compatible land use issues, support military
14 families, and increase military, civilian, and in-
15 dustrial readiness and resiliency; and

16 “(B) providing adjustment and diversifica-
17 tion assistance to State and local governments
18 under section 2391(b) to achieve the objectives
19 described in subparagraph (A);

20 “(2) coordinate the provision of such assistance
21 with other organizations and elements of the De-
22 partment;

23 “(3) provide support to the Economic Adjust-
24 ment Committee established under Executive Order

1 12788 (57 Fed. Reg. 2213; 10 U.S.C. 2391 note) or
2 any successor to such Committee; and

3 “(4) carry out such other activities as the Sec-
4 etary of Defense determines appropriate.”.

5 (2) CLERICAL AMENDMENT.—The table of sec-
6 tions at the beginning of such chapter is amended
7 by inserting after the item relating to section 2391
8 the following new item:

“2391a. Office of Defense Community Cooperation and Economic Adjustment.”.

9 (b) TRANSFERS.—Not later than 180 days after the
10 date of the enactment of this Act, the Secretary of Defense
11 shall transfer the functions, personnel, and assets of the
12 Office of Economic Adjustment of the Department of De-
13 fense to the Office of Defense Community Cooperation
14 and Economic Adjustment established under section
15 2391a of title 10, United States Code (as added by sub-
16 section (a)).

17 (c) ADMINISTRATION OF CERTAIN PROGRAMS.—Be-
18 ginning on the effective date of the transfers under sub-
19 section (b), any program, project, or other activity admin-
20 istered by the Office of Economic Adjustment of the De-
21 partment of Defense as of the date of the enactment of
22 this Act shall be administered by the Office of Defense
23 Community Cooperation and Economic Adjustment estab-
