Ms. CRAIG introduced the following bill; which was referred to the Committee on Ways and Means

A BILL

To amend title II of the Social Security Act relating to the sharing of death information with the Do Not Pay working system, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Social Security Pay-
5 ment Integrity and Information Act of 2022”.

6 **SEC. 2. SHARING OF DEATH INFORMATION WITH DO NOT**
7 **PAY WORKING SYSTEM.**

8 (a) IN GENERAL.—Section 205(r) of the Social Secu-
9 rity Act (42 U.S.C. 405(r)) is amended—

1 (1) in paragraph (2)—

2 (A) in subparagraph (A), by moving the
3 margins for each of clauses (i) and (ii) 4 ems
4 to the left; and

5 (B) by moving the margins for each of
6 subparagraphs (B) and (C) 4 ems to the left;

7 (2) in paragraph (3)(A), by moving the margins
8 for each of clauses (i) and (ii) 2 ems to the left;

9 (3) by moving the margins for paragraph (7) 2
10 ems to the left; and

11 (4) by adding at the end the following:

12 “(11) The Commissioner of Social Security may, im-
13 mediately upon the date of enactment of this paragraph,
14 and shall, beginning not later than December 27, 2022,
15 provide information furnished to the Commissioner under
16 paragraph (1) to the agency operating the Do Not Pay
17 working system described in section 3354(e) of title 31,
18 United States Code, to prevent improper payments to de-
19 ceased individuals through a cooperative agreement with
20 such agency, provided that the requirements of subpara-
21 graphs (A) and (B) of paragraph (3) are met with respect
22 to such agreement with such agency.”.

23 (b) CONFORMING AMENDMENT.—Section 801 of divi-
24 sion FF of the Consolidated Appropriations Act, 2021
25 (Public Law 116–260) is amended—

- 1 (1) in subsection (a)—
2 (A) by striking “(a) IN GENERAL.—”;
3 (B) at the end of paragraph (6), by strik-
4 ing “; and” and inserting a period; and
5 (C) by striking paragraph (7); and
6 (2) by striking subsection (b).
