Mr. BISHOP of North Carolina (for himself, Mr. GAETZ, Mr. BIGGS, and Mr. BUDD) introduced the following bill; which was referred to the Committee on Oversight and Reform

A BILL

To prohibit certain Federal funding to governmental entities that permit autonomous zones within their borders, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “CHOPping Cash for
5 CHAZ Act of 2020”.

1 **SEC. 2. FUNDING PROHIBITION RELATING TO AUTONO-**
2 **MOUS ZONES.**

3 (a) **IN GENERAL.**—During fiscal year 2021, no Fed-
4 eral funds may be provided to a covered governmental en-
5 tity—

6 (1) that permits, for a period exceeding 7 days,
7 an autonomous zone to exist within the jurisdiction
8 of such entity; and

9 (2) until such time as such entity satisfies the
10 requirements specified in subsection (c).

11 (b) **REGULATIONS.**—

12 (1) **IN GENERAL.**—Not later than 15 days after
13 the date of enactment of this Act, the Attorney Gen-
14 eral shall issue regulations necessary to carry out
15 this section, including regulations establishing stand-
16 ards for determining, for purposes of subsection (a),
17 what constitutes—

18 (A) an autonomous zone; and

19 (B) activities that permit such a zone to
20 exist.

21 (2) **ANTIFA CONSIDERED.**—In determining
22 what constitutes an autonomous zone, the Attorney
23 General shall incorporate consideration of the pres-
24 ence of ANTIFA within the zone.

25 (c) **REESTABLISHING ELIGIBILITY.**—To reestablish
26 eligibility for Federal funds, a covered governmental entity

1 subject to the funding prohibition under subsection (a)
2 shall—

3 (1) disband the relevant autonomous zone; and

4 (2) submit to the Attorney General a report de-
5 tailing—

6 (A) the manner in which the autonomous
7 zone was disbanded; and

8 (B) how the entity intends to prevent fu-
9 ture establishment of autonomous zones.

10 (d) COVERED GOVERNMENTAL ENTITY DEFINED.—

11 In this section, the term “covered governmental entity”
12 means each of the following:

13 (1) A State.

14 (2) A territory of the United States.

15 (3) A political subdivision of an entity described
16 in this subsection, including a city or town.
