A BILL

To amend the Legislative Reorganization Act of 1946 to reduce the rates of pay of Members of Congress during a fiscal year if Congress has not agreed to a concurrent resolution on the budget for such fiscal year, to repeal the automatic appropriation of funds for the salaries of Members of Congress, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Do Your Job Act”.

1 **SEC. 2. REDUCTION IN RATES OF PAY FOR MEMBERS OF**
2 **CONGRESS FOR FAILURE TO AGREE TO**
3 **BUDGET RESOLUTION.**

4 (a) REDUCTION.—Section 601(a)(2) of the Legisla-
5 tive Reorganization Act of 1946 (2 U.S.C. 4501(2)) is
6 amended to read as follows:

7 “(2) If, by the first day of a fiscal year, both Houses
8 of Congress have not agreed to a concurrent resolution
9 on the budget pursuant to section 301 of the Congres-
10 sional Budget Act of 1974 for such fiscal year, the annual
11 rate of pay for each of the positions described in para-
12 graph (1) for pay periods occurring during such fiscal year
13 shall be equal to 90 percent of the annual rate of pay for
14 such position for the most recent pay period preceding
15 such fiscal year.”.

16 (b) EFFECTIVE DATE.—The amendment made by
17 subsection (a) shall apply with respect to pay periods oc-
18 ccurring after the date of the regularly scheduled general
19 election for Federal office held in November 2024.

20 **SEC. 3. REPEAL OF AUTOMATIC APPROPRIATION OF SALA-**
21 **RIES OF MEMBERS OF CONGRESS.**

22 (a) REPEAL.—Effective with respect to each fiscal
23 year beginning on or after the date of the enactment of
24 this Act, section 130(c) of Public Law 97–51 (2 U.S.C.
25 4502) is repealed.

1 (b) CONFORMING AMENDMENT.—Section 601(a)(1)
2 of the Legislative Reorganization Act of 1946 (2 U.S.C.
3 4501(1)) is amended by striking “The annual rate of pay”
4 and inserting “Subject to the availability of appropria-
5 tions, the annual rate of pay”.
