Mr. David P. Roe of Tennessee introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To direct the Secretary of Veterans Affairs to conduct and support research on the efficacy and safety of medicinal cannabis, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. CONDUCT OF RESEARCH INTO EFFECTS OF
- 4 CANNABIS ON HEALTH OUTCOMES OF CER-
- 5 TAIN VETERANS.
- 6 (a) Research.—In carrying out the responsibilities
- 7 of the Secretary of Veterans Affairs under section 7303
- 8 of title 38, United States Code, the Secretary shall con-
- 9 duct and support research relating to the efficacy and
- 10 safety of forms of cannabis described in subsection (c) on

1	the health outcomes of covered veterans diagnosed with
2	chronic pain, post-traumatic stress disorder, and other
3	conditions the Secretary determines appropriate. The Sec-
4	retary shall ensure that such research is conducted in ac-
5	cordance with applicable regulations relating to the over-
6	sight of research, including such regulations prescribed by
7	the Office of Research and Development of the Depart-
8	ment of Veterans Affairs, the Department of Health and
9	Human Services (including through the National Institute
10	on Drug Abuse), the Food and Drug Administration, the
11	Drug Enforcement Administration, and the National In-
12	stitutes of Health.
13	(b) Data Preservation.—Research conducted pur-
14	suant to subsection (a) shall include a mechanism to en-
15	sure the preservation of all data, including all data sets,
16	collected or used for purposes of the research required by
17	subsection (a) in a manner that will facilitate further re-
18	search.
19	(c) Forms of Cannabis To Be Researched.—The
20	forms of cannabis described in this subsection are—
21	(1) varying forms of cannabis, including—
22	(A) full plants and extracts;
23	(B) at least three different strains of can-
24	nabis with significant variants in phenotypic
25	traits and various ratios of tetrahydrocannabi-

1	nol and cannabidiol in chemical composition;
2	and
3	(C) other chemical analogs of tetrahydro-
4	cannabinol; and
5	(2) varying methods of cannabis delivery, in-
6	cluding topical application, combustible and non-
7	combustible inhalation, and ingestion.
8	(d) Implementation.—In conducting and sup-
9	porting research under subsection (a), the Secretary
10	shall—
11	(1) before conducting and supporting such re-
12	search, develop a plan to implement this section and
13	submit such plan to the Committees on Veterans'
14	Affairs of the House of Representatives and the Sen-
15	ate; and
16	(2) issue any requests for proposals the Sec-
17	retary determines appropriate for such implementa-
18	tion.
19	(e) Reports.—During the five-year period beginning
20	on the date of the enactment of this Act, the Secretary
21	shall submit periodically, but not less frequently than an-
22	nually, to the Committees on Veterans' Affairs of the
23	House of Representatives and the Senate reports on the
24	implementation of this section.

- 1 (f) COVERED VETERAN DEFINED.—In this section,
- 2 the term "covered veteran" means a veteran who is en-
- 3 rolled in the patient enrollment system of the Department
- 4 of Veterans Affairs under section 1705 of title 38, United

5 States Code.
